I. Call to Order @ 8:35

Blanca Cavazos

a. Review/Additions/Deletions and Approval of Agenda

c. Approval of Minutes

The minutes were reviewed by the group. A motion for approval of the minutes came from John Snavely and it was seconded by Bill Black. The minutes were approved unanimously.

II. The Vergara Case

Frank Fekete

Mr. Frank Fekete was introduced by Dr. Cavazos. Mr. Fekete discussed his background with school legal issues and stated that he still works as a consultant on educational matters around the state. He received a call from one of the largest law firms in the state to become an expert witness on the Vergara case. This case involves matter that relates the California constitution more so than the US Constitution. The Serrano II case was the foundation of a denial of equal protection of students and one of the foundations of Vergara. Keeping incompetent teachers and laying off junior superior teachers is the basis of Vergara. Prior to 1983 the probationary period was three years. The probationary period was changed from three years to two at the request of district administrations because for a three year dismissal, there had to be an actual case to present to the board, and districts found it cumbersome and costly. The bad news of switching to a two year probationary period was that administrators were left with only 16 months to make an informed decision on whether a teacher has what it takes. A district's own bargaining agreements= can also hamper the need to make appropriate decisions on these matters. The layoff statute essentially says that, with very few exceptions, layoffs must be made by seniority rather than professional proficiency. The third set of statues was the permanent teacher dismissal statute. There are 17 steps to firing a permanent certificated employee. The judge called this "Due Process on Steroids, or Uber Due Process". Mr. Fekete stated that \$50,000 to \$400,000 is the current range of the cost of dismissing a teacher. By comparison, the costs comparison for classified permanent employee was \$3,400. The consequence is, "The teachers don't get fired". Only 2.3% of teachers in

California cases of teachers determined to be incompetent to teach end in a dismissal. Over at10 year period there were only 120 actual decisions made with districts only winning 60 of the cases which is 0008% of teachers per year were dismissed. The judge ultimately didn't resolve any significant language in his decisions on the case other than some damaging comments that made national media headlines. The case has currently gone to the court of appeal and we can expect the case to move forward slowly unless there is legislation that intervenes on the matter. There is much more pressure on the site administrators to have solid evaluations that will create the case needed to actually dismiss a teacher. Most California administrators are currently not trained to conduct effective evaluations and most evaluations done today will not be enough. There needs to be more pressure from the outside, and Mr. Fekete doesn't believe the courts will come to a decision. He felt that the legislature will be the ones that will actually make any effective and lasting change in the law.

- Craig Wheaton discussed a proposed new governance structure from an ACSA task force. The changes are "significant" in how ACSA will make decisions in the future. Two handouts were provided to the members present.
- State ACSA "studied" effective governance and sound principals of good governance and a task force looked at the vision of ACSA and made recommendations that would streamline ACSAs services. All aspects of ACSA systems were reviewed.
- Recommendations were directed at ACSA Board Composition and Election, Delegate Assembly Role and Composition, and Role of Regions and Charters.

ACSA Board Composition and Election: Recommend smaller, more nimble, and efficient Board. Set clear qualifications for the selection of board members to ensure the proper skill set to ensure they meet the needs of the group. Also considered were "geographical" representation of board members – creating 6 instead of 19 board members.

Concerns: Group comments: Understand the need for a nimble board. Concern: adequate representation without strongholds of power. The top layer of ACSA governance could take the place of major changes in structure by giving that group more power to make decisions.

Delegate Assembly Role and Composition: Renamed ACSA Leadership Council. The president and president-elect of each region, committee and council chairs, the ACSA Board of Directors would be the members. The focus of the group would be to elect the ACSA Board as well as the usual continued work of the assembly.

Concerns: If other regions don't align as we align then it encourages Regions to expand their number of charters. Delegate assembly is a place where ACSA members feel that they have a voice. Three times a year, the voice of members is heard at the State level.

Role of Regions and Charters: Some regions have charters that are completely independent of the Region. Region XI is actually the "model" of how an ACSA Region should be structured. Structures and governance vary widely across the State. It appears that the proposed changes in this area will not impact our Region because many of the proposed changes are already in place here.

Concerns: Who determines the plan? Are rebates effected by the plan's development?

- Terri and Craig asked the members to meet as a group and write down concerns, likes, and dislikes of these proposed changes to take back to the task force and State ACSA. The group spent 10 minutes on the topic and all groups were provided feedback.
- At the delegate assembly in May, final recommendations will be called for to allow top-level leaders to meet over the summer to finalize the changes. Regions can expect changes in the bylaws in the coming years on these topics. Craig Wheaton is the voice for our region, so if members have questions or concerns, they need to contact him directly.
