

Members of the Human Resources (HR) Council met January 16, prior to the Negotiators Symposium in San Diego. One "hot topic" the group discussed involved the Commission on Teacher Credentialing (CTC). Leadership members from the CTC are strongly advocating to be allowed to review teacher credentials from every school district annually. There are several potential ramifications if this newest proposal goes through as reported:

- Sanctions may be given to any district that receives findings;
- 2) Any teacher who is "mis-assigned" by a district would be encouraged to work through the "local process" to correct it, and then report the mis-assignment to his/her county office of education; and
- Any adverse action against this teacher (and each evaluation) would be rendered null and void if given when mis-assigned.

The Middle Grades Education Council (MGEC) met January 18 via Web- Ex. The ACSA Mission Statement was reviewed. The purpose of the MGEC was read and discussed. Michael Tsuboi, of Region XI, was voted to be the president of the MGEC. A comprehensive overview of Schoology was presented and many links that connect with the ACSA website were demonstrated. A follow up to the CA Standards Implementation matrix was conducted. 21st Century learning exemplary website was demonstrated and the schools that were selected were suggested to be visited for ideas for our own schools. My Digital Chalkboard was demonstrated as an excellent resource for teachers and students. A discussion sharing resources and best practices for social emotional education for students was held. Tolerance and engagement were stressed as important factors. The Collaborative for Academic, Social, and Emotional Learning (CASEL) was shared by D. Militzer as a resource for Social and Emotional Learning (SEL). The next meeting will be March 8 in Sacramento.

Retirement Committee

- The State Retirement Committee met on Nov. 1 in San Jose.
- 1) The committee requested the National Association of School Superintendents to take a strong position recommending action to address Social Security issues of the Windfall Elimina-

- tion Provision and the Government Pension Offset as a priority in their legislative action
- The committee continued ongoing discussion requesting the CalSTRS board to increase and
- 3) equalize the one-time death benefit. While all members have the \$6,163.00 death benefit after retirement, the pre-retirement death benefit for members active before 10/15/1992 is different than for those active after that date
- 4) There are approximately 350 STRS members over 100 years of age. This is a concern for older retirees who are not guaranteed a 2% non-compounded annual increase
- 5) The committee continues to endorse the Ambassador program
- 6) Employer contributions to Cal-STRS is 13.4% this year. Cal-STRS funding status is on track to full funding by 2046 with the following risks: increased life expectancy, decline in membership (e.g. charter school members opting out of pensions), unrealistic assumed rate of return at 7%, projecting the employer rate decline to 18% by 2023, investment divestiture pushed by state officers and legislature risks high rates of return to pension funds and hamstrings the investment board in making the best decisions regarding high returns to the fund (i.e. \$5 billion loss to STRS by divesting from tobacco products)
- 7) The committee continues to push for information and transparency regarding the CalSTRS board attempts to fund a new building and increase staffing.

The committee's next meeting is March 28 in Sacramento.

Inyo/Mono Charter member Stacey Adler, Ph.D., Superintendent of Schools with the Mono County Office of Education, will serve as president of the California County Superintendents Education Services Association (CC-SESA) in 2018.

Take a few moments to get to know her, learn about CCSESA, and how ACSA and CCSESA compliment each other to make a difference for California's students.

Tell us about the career path that lead you to your present position as Superintendent of Schools with the Mono County Office of Education.

After receiving my Masters' Degree in Teaching from National-Louis University (Evanston, IL), I moved to California and began my teaching career. I mostly taught at the elementary level and loved every minute of it. One of my principals suggested I pursue my administrative credential and after I earned that, I was hired for my first principalship at the Temecula Learning Center. Following a few other administrative positions in southern California, my husband and I decided to make the move to Mammoth Lakes, where I was hired as the elementary school principal. Four years later, I went over to the Mono County Office of Education as the Assistant Superintendent

of Curriculum and Instruction. It was a big surprise to me when my predecessor decided to retire and appointed me Superintendent. That was eight years ago – time really flies!

As you assume the presidency of CCSESA for 2018, explain the association's mission and what you hope to accomplish during your tenure.

CCSESA's mission is to strengthen the service and leadership capabilities of California's 58 County Superintendents in support of students, schools, districts and communities.

There is so much going on in education right now. In addition to building our communication efforts as an organization, I am hoping to continue working with my colleagues to promote the work of County Offices, especially in the areas of assisting our districts with continuous improvement and implementing the state curriculum standards.

How can your ACSA membership help you to accomplish these goals?

LCFF provides an opportunity for meaningful local control and relies heavily on the collaborative working relationships of county offices and the school districts in each county. ACSA plays a big role in working with CCSESA in building and supporting this collaborative relationship. As we continue to move down the path of supporting districts and not forcing compliance, ACSA plays a key role in helping new administrators as they navigate differentiated assistance. As a new administrator I attended several different ACSA symposiums and conferences and always came

away from those with ideas and strategies that I could apply the next day. I think those professional development opportunities can play a role supporting the district administrators alongside of the county offices.

What is the most rewarding part of the work you do?

Definitely any time I can do something with students that is always rewarding. I volunteer in one of the elementary schools in my county and I have such a blast! As a County Superintendent I have opportunity to put programs in place that are meaningful to all community members, such as the Choose Civility Initiative we did a few years back, the Trails to Literacy program we just began last year and partnering with the Mono Arts Council to bring art and music programs to all students across our county. Bringing these, and other programs, to our communities is not only rewarding, but an honor.

What is the best advice you have given to others?

The best advice I have given to others is to always be kind. You can never go wrong if you are always kind.

Tell us about your family and what you enjoy doing in your free time.

My husband, Joe and I have been married for 20 years. We have three kids, Brody, Sarah and Tessa. We really enjoy spending time together – playing games (UNO is a current favorite), going hiking, and traveling. I enjoy reading and, although this is very old fashioned, I do needlepoint at night.

Mentoring is an excellent way to provide on the job, confidential, practical support for new administrators, and possibly the best aspect is that the service is absolutely FREE to ACSA members. Each and every time a district hires an administrator, the district is making a substantial investment. It simply makes sense to develop and protect that investment, and the Mentor Program is a great starting point. We are encouraging all superintendents to let their new administrators know of the program and encourage them to participate.

Within the Association of California School Administrators, our goal is to improve the effectiveness of administrative leaders, thereby increasing the success of their students, and protecting the investment that is administrative personnel. District and school administrators are expected to be great leaders from the very beginning of their careers, but the framework to hone their leadership skills primarily occurs prior to their gaining practical experience.

The Mentor Program is coordinated by retired administrators Marc Ecker and John Almond, and they have secured the

services of a diverse cadre of regional facilitators. These facilitators are highly skilled, experienced, and motivated educational leaders who have accepted the responsibility to oversee the mentor/protégé relationships in their respective geographic areas. These facilitators have all had very successful careers and understand the qualifications and characteristics necessary to be a positive mentor for a protégé.

The Mentor Program is one of the many professional development opportunities offered by ACSA, and, during this past year, our regional facilitators were responsible for establishing approximately 100 mentor/protégé relationships.

Feedback from participants has been very positive, and it is our hope that even more new administrators will take advantage of this program in the coming year. We began with superintendents and have now moved on to include site administrators, especially principals, and district office staff. Basically, the program is open to all first and second year administrators that are new to their position.


Workshop aims to build a successful attendance improvement plan

About 40 superintendents from throughout Region XI attended ACSA's Superintendents' Symposium in Monterey recently. This annual event brings school leaders from around the state together for an invaluable two-and-ahalf days of professional learning, networking and advocacy. This symposium offered superintendents an opportunity to get together to review the governor's budget and to review the state-of-the-state and the state-

of-the-district. The fact that this is the time for


