





We cannot continue to complain about the status quo while continuing to elect leaders who will protect that same status quo. We look forward to working with Tuck to find solutions and make needed changes to public education that continues to leave California's school system and students behind. We look forward to hearing from Tuck in person at our April 5 meeting and posing critical questions to him so that our region can get to know the candidate better.

Goal 2:

We will increase support from top administrators to build meaningful involvement for members and districts.

In addition to the multitude of charter conferences offering premier professional development and networking socials, we surveyed our region to develop a tentative plan to offer region academies for the 2018-2019 academic year. During 2017-2018 our region hosted Curriculum & Instructional Leaders

throughout California will walk the halls of the Capitol advocating for additional time to determine whether to keep a teacher by increasing the probationary period to three years and enacting a plan to increase state funding per pupil to at least the average of state funding per pupil nationally. You can participate. Let your charter president know you would like to represent your charter at Legislative Action Day. Your travel and lodging will be paid by the region/charter.

One of the goals of the region is to connect with state legislators. That has happened. Charters and the region have met

with legislators who represent our region, listening to their thoughts, sharing our concerns and advocating for students. As a result of a meeting in Kings Charter, Assemblyman Andy Vidak said he will be sending a representative from his office or he will be attending all future meetings to listen and address concerns in the legislature.

At the last region board meeting, ACSA Executive Director Wes Smith addressed the board followed by Delaine Eastin, former State Superintendent of Public Instruction and current candidate for governor. Marshall Tuck, the candidate ACSA has endorsed for State Superintendent of Public Instruction, will address the Leadership Assembly in April.

County who work collaboratively to solve issues that prevent students from receiving the education they deserve. In the afternoon, Smith met privately with Mary Barlow, Kern County Superintendent of Schools; Bryan Schaefer, Kern High School District Superintendent; Doc Ervin, Bakersfield City School District Superintendent; and Blanca Cavazos, Taft Union High School District Superintendent and member of the ACSA State Board of Directors. The purpose of the meeting was to discuss how ACSA can best serve and attract administrators in Kern County and specifically, in the two largest districts in the county — Bakersfield City School District and Kern High School District, which are also the largest districts in the state to serve their grade span. Excellent recommendations were made by the superintendents. The ACSA Member Services team will be following up on the recommendations.

"This meeting was two years in the making because of scheduling conflicts and other extenuating circumstances," said Cavazos. "We are delighted to finally have our ACSA Executive Director in Region XI." He shared that he had made many visits to Kern County in his youth because his aunt and uncle lived in Bakersfield. "Although it has changed a lot in the intervening years, I am glad to be back," he said. Facilitated by Cavazos, these meetings were considered a rousing success. "Everyone was completely focused on what Wes was saying," Dr. Cavazos said. "I know it made an impact on the groups he met with."

He asked members to join ACSA in changing the conversation around education. He said that typically the conversation is dominated by the interests of adults and special interest groups. "As you talk to folks about why they should be part of this movement, tell them California needs to put its students at the front of every conversation related to public education," he said.

Smith finished up his visit to Region XI by addressing the Region XI Board Meeting. He talked about the year-long effort by the State Board to develop a new strategic plan. "The old one was really aggressive and worked very well, but it's time for a new one," he said. Much effort has been put into

Educators focus on ‘Leading from the Inside Out’ at Mid-State Conference

Organizers of this year’s Mid-State Conference chose to put the focus on the social and emotional well-being of both educators and students. Featured speakers Kelli Rizzi, Joelle Hood, Terry Deal and Trudy Arriaga all followed this theme, bringing a their own spin on the subject.

In its third year, the conference was held St. Patrick’s Day weekend at the Embassy Suites Hotel in San Luis Obispo, presented by ACSA Regions 9, 10, 11 and 13,

As a prequel to the conference, Kelli Rizzi, Director of School and District Support with the Shasta County Office of Education, presented a workshop about Trauma Informed Practices. Rizzi has been trained through Dr. Bruce Perry’s Trauma Academy in the Neurosequential Model of Education. Rizzi explained that Trauma Informed

Practices are the link to academic achievement and social/emotional success for students who’ve experienced toxic stress and trauma. She shared methods and practices to help teachers and students be better regulated in order to decrease behavior issues and open the mind for learning.

Randy Bangs, conference chairman, opened the conference at dinner Friday evening. ACSA President Lisa Gonzales welcomed the crowd and introduced ACSA-endorsed candidate for State Superintendent of Public Instruction (SPI) Marshall Tuck. Gonzales and Tuck sat down for an informal town hall-style interview. Members of the audience were able to submit questions via their electronic devices, which Gonzales then posed to Tuck, along with some previously prepared questions.

True to her goal to include family in ACSA activities, Gonzales called upon her twin daughters, Landry and Kennedy, to pose one question each to Tuck. Tuck said he believes public education should be the top priority, that California has neglected education for decades. He proposes a 10-year plan to bring education back to

where it was prior to the passage of Prop 13. “A lot of people blame our educators for the challenges in our public schools. Teachers did not underfund their classrooms. Principals and superintendents did not smother their schools and districts in red tape,” Tuck said. As SPI, Tuck sees it as his responsibility to represent the interests of educators and students to state legislators and the governor.

Joelle Hood was the featured presenter for the evening. She is an advocate for youth and is committed to incorporating social emotional learning into schools so that they can help prepare students to become the best that they can be, and help make the world a better place at the same time. Her presentation for the evening focused on “mindfulness,” particularly as it pertains to the social and emotional health of educators. She walked the audience through several exercises designed to increase mindfulness and empathy. “Empathy is a learned skill and a choice. When you communicate with empathy, it turns me into we,” she said.

Nearly 30 breakout sessions were offered throughout the day on Saturday. With so many choices, there was something for everyone. “The sessions were good and relevant to the current climate in education,” said Traci Minjares, Principal, Cummings Valley Elementary School in Tehachapi. “I enjoyed connecting with other administrators outside my district.” Kings Charter’s President Rodney Brumit, Principal at Lemoore High School, brought members of his staff to present a session on building resilient students. They explained

how Lemoore High School implements a system that provides intervention and support to all students, creating an environment of respect, responsibility and resiliency. Presenting with Brumit were Assistant Principal Nicole Moore and School Psychologists Kris Saavedra and Chelsea Bowling.

ACSA Executive Director Wes Smith opened the second general session with a brief ACSA update. "The power of ACSA is in the collective strength of its members," he said. "ACSA is focused on two things — benefitting the kids of California and serving you, the members of ACSA."

The featured speaker for the second general session was Terry Deal, award-winning educator, author and international consultant to business, health

care, military, educational and religious organizations. The focus of his presentation was leading with soul. He explained that capitalizing on and nurturing employees' soft skills — being a good coach, community well being, empathy, critical thinking, being able to make connections — are what make a successful organization.

In a message directly aimed at educators, he said, "Any of you could go into a corporate office, you could do the work, you'd probably make much more money, but you'll never ever make the difference that you do."

Saturday afternoon, the ACSA Government Relations Team took time to discuss legislative issues they are currently addressing. Michele Borges, Principal at Mission Oak High School in Tulare, attended this presentation and found it very informative. "Not only does the Mid-State Conference give me a chance to network and learn from other leaders throughout California, it provides an opportunity to hear from our ACSA Government Relations Team to learn about the most recent areas of focus in California legislation," Borges said.

Throughout the day Saturday, attendees were encouraged to visit the conference partners/exhibitors and have their bingo card signed off. Cosner expressed his enthusiasm for the conference as a whole this way, "The experience was a tremendously refreshing way to spend time with brilliantly successful leaders more than willing to help others on their journey."

ACSA Vice President of Legislative Action Terri Rufert opened the final general session and introduced featured speaker Dr. Trudy Arriaga, who has focused her life work on the fundamental belief

For example, Fruitvale Junior High School in Bakersfield has created an outstanding forensic medical science program, allowing students to experience science hands-on and use their skills of analysis, inquiry and observation.

To earn this designation, schools must complete an extensive application that is reviewed by middle grades experts. In order to retain the designation, each school is re-evaluated every three years. Get to know Fruitvale Junior High School (FJHS) leadership

Tell us about the career path that lead you to your present position.

- **Principal Leslie Garrison:** Prior to teaching I was in children's ministry. When my own children started school I began my teaching career as an 8th grade mathematics teacher in the Rosedale School District. While at Rosedale I served as the administrative designee and participated in the Principal's Academy to prepare for a future administrative position. While teaching, I had a unique opportunity to move into a Superintendent/Principal position for a small rural school district outside of my hometown of Taft. I served two years in that capacity when I was offered an administrative position in the Fruitvale District. I have been at FJHS for the past 10 years. During that time we have received recognition as a California Distinguished School (2013), Gold Ribbon School (2017), and now a School to Watch (2018). I am grateful for my path and honored to work with such an incredible district, school staff and community.
- **Assistant Principal Erick Rouanzoin:** Prior to getting into education I worked as a police officer for the City of Long Beach. I left law enforcement to help at-risk youth in a Title 1 school site. I taught history and created the first Tier3 Positive Behavioral Support Class in Orange County. I had connections in the Bakersfield area and when I saw an administrative position available in Fruitvale I jumped at the chance. This is my second year as assistant principal and I am excited for the future of FJHS.

What advice would you offer other schools which would like to achieve this designation?

Garrison and Rouanzoin: The program is rigorous and the application process is well defined. Schools begin with a self-assessment exercise in which all staff con-

tribute perspective on the school's success in four focus areas — Academic Excellence, Organizational Support and Processes, Social Equity and Developmental Responsiveness. Our advice is to examine your results, determine if you are at a level to celebrate, and seek the best practices within your school that other schools can replicate. Finally, celebrate your accomplishments!!! Your staff, students and community are

making an impact on kids and that is worth recognizing! Then, be sure to visit other schools which have achieved this designation and attend the conferences. The schools recognized are exceptional. In the short time of our designation we have already visited and gleaned valuable practices that we intend to incorporate into our campus for continued improvement.

What is the most rewarding part of the work you do.

Garrison: The most rewarding part of what I do is building relationships that foster learning and growth. I relish in connecting with staff members, supporting them in their lives and careers, and in-turn, impacting student success. The best part of my day is talking with students, making genuine connections, walking them through the most confusing stage in their lives, and seeing them recognize their worth.

Rouanzoin: The most rewarding part of my work is making an impact on an entire campus. Junior High can be one of the most difficult periods of time for the socio-emotional and behavioral health of students. In my role, I have the opportunity to walk students through this time of growth, impact their decisions for the better, and connect them to caring staff.

How has your ACSA membership helped you accomplish your goals?

Garrison: ACSA members are the most valuable aspect of membership as they are all exceptional leaders and professionals. The connections and friendships are invaluable. ACSA has many other facets of support that I have taken advantage of — financial advice, car insurance, legal advice and professional development! I am grateful for my membership!

Rouanzoin: ACSA members are a group of professionals that I can learn from and lean on. As I am new to the area, ACSA has been a great resource, not only in the wealth of knowledge of the members, but the connections to the community.

Tell us about your family and what you enjoy doing in your free time?

Garrison: My husband and I have a blended family; we have three children in college and one in pre-school. We are a very athletic family which likes to ride bikes, swim, snorkel, and remain active. Leg Action Day messaging will focus on teacher tenure and increasing base funding



The ACSA Board of Directors met in Garden Grove on Friday, Feb. 16. State ACSA Vice President Linda Kaminski reported on the work done by the Finance Committee, which has adopted a conservative and realistic budget process. Revenues have increased over last year and mid-year budget revisions have been made. The Rainy Day Fund is on target and should reach \$500,000 by the end of year. ACSA is now reviewing the budget in the same transparent manner as school districts. Although ACSA currently has more than 17,000 members, there is concern that this is the first time in five years that there has been a dip in membership.

Legislative Action Day is scheduled for Sunday and Monday, April 15 and 16, in Sacramento. The messaging for Legislative Action Day will focus on two topics: Increasing the base funding and adding time for teacher tenure review. The goal is to disseminate real stories about how these topics impact students. Although school safety is on everyone's mind, this topic will not be a

focus during Legislative Action Day due to concerns that lobbying on school safety may not be substantive during this event. Instead, State ACSA President-Elect Holly Edds will be leveraging a new task force to address this issue. During the Legislative Action Day event, Senator Mike McGuire and Karen Stapf-Walters will be recognized with the ACSA Friend of Education Award. McGuire was unanimously recommended for the award because of his coordinated efforts to provide funding, clothing and other resources for students and families affected by the California fires. Stapf-Walters has previously worked for ACSA and is one of our own. She advocates for students on the State Board of Education and in her work as an aide to Governor Jerry Brown.

The board held an extensive discussion regarding language clarification of policy 6.11.1, the election of officers. The primary question is, "How do we ensure that candidates have an equal opportunity to campaign when running for state ACSA office?" The current regulations and policies on campaigning are vague and force candidates and the board to interpret the rules. In the current and previous campaigns for office, some candidates have been active in serving on boards, committees or councils and/or in presenting at ACSA-sponsored events. These candidates have had to limit their participation while campaigning so as to not gain an unfair advantage over their competitor, who will then have less exposure to the ACSA membership. After much debate, the board voted to edit policy 6.11.1 clarifying that while campaigning will be limited, service and participation in ACSA activities will not. The board also directed staff to bring back recommendations for the next meeting to clarify campaigning and associated prohibitions.

A discussion was held regarding the endorsement of Marshall Tuck for Superintendent of Public Instruction. The discussion focused on two areas: Region procedures and feedback from the activity at the Leadership Assembly. As a result, the Governmental Relations (GR) team will roll out a hybrid communication plan that will focus on members and the general public, through sharing of internal talking points, external talking points, a presence on social media and our website, the utilization of the press (opinion/editorials, press releases, etc.), continuing to provide opportunities for Tuck to engage with our members through ACSA-sponsored events and by creating and providing informational materials for region use. The ACSA GR department will improve communications by providing a timeline to all regions so officials know what is going on and when. They will also explore different ways and forms to conduct advocacy communications activities. In regard to the gubernatorial race, we

should have a clearer picture of who is really in the race this summer. Staff has suggested that the board wait until then before considering an endorsement for a candidate. The GR staff recommends that regions begin discussions regarding the gubernatorial race. A timeline will be distributed to regions so members are clear on the process.

The National Association of School Superintendents (NASS) Executive Director Tom Armelino presented an update on the activities of the association. The ACSA Board of Directors approved NASS's articles of incorporation and adopted bylaws changes that are reflective of ACSA's bylaws. The new bylaws outline that the current ACSA Board of Directors is the NASS board and would meet at least twice per year. The NASS/ACSA executive committee would be the same. ACSA Board of Directors approved the recommendation to establish a NASS Superintendents Committee similar to ACSA Superintendents Council.

ACSA's One Voice for Students Platform was shared. Our priority areas are: School finance, educator effectiveness and pipeline, Special Education, and student needs. Some highlights include: Ensuring the full funding of Proposition 98, setting a new LCFF multi-year target, mitigating the impact of pensions, protecting Title II funding, extending the teacher probationary period, advocating for the reauthorization of IDEA, and expanding access to behavioral and mental health services.

The development of ACSA's strategic plan was also discussed. The board reviewed the timeline and accomplishments of the four Core Planning Group (CPG) meetings. There will be additional work conducted by the CPG at the May Leadership Assembly in Sacramento. By mid-June, the CPG will develop a final draft for implementation and the board will receive the draft final version at the July retreat.



"It's a whole culture that none of us have any idea about and are not equipped to deal with," said Bobby Peters, Director of Educational Services, Hanford Joint Union High School District. The senator thanked the group for the information and said, "From just what I heard today, sometimes we're battling about things that are not even addressing what you guys are talking about. AB3149, Substitute Teachers; Days of Service by Asm. Monique Limon, a former trustee in CALSSD-member district Santa Barbara USD. This bill was just brought to our attention and we think it helps resolve an issue. AB3149 would permit a person authorized to serve as a substitute teacher pursuant to regulations, to serve as a substitute teacher for as long as the teacher of record is on leave. The bill is sponsored by ACSA.

Small School District Committee

▶ The Small School District Committee met on Friday, Feb. 16. The committee reviewed and discussed a variety of topics including, but not limited to, the following:

- 1 - Concerns surrounding the new credentialing requirements for administrators (assessment requirements, cost, etc.)
- 2 - Review of the Superintendent's Symposium, at which the Small School sessions were well attended. Discussion was also conducted around next year's topics.
- 3 - Committee Chair Don Clark (termining out) emphasized the

need to make sure to keep a powerful and meaningful voice on behalf of Small School Districts.

4 - There was discussion around ACSA's support of Marshall Tuck for Superintendent of Public Instruction (the how and why).

5 - West Ed (Ayele Dodoo) presented on the California Standards Implementation Matrix and the four domains — Instructional Leadership, Challenging Standards, Quality Curriculum and Effective Assessment. The tool was designed to accelerate the implementation of the California State Standards in districts and schools.

6 - Information from Ivan Carrillo, regarding priority areas at the Leadership Assembly — Pensions, Extended Substitute Times in the Classroom, the 3 -Year Probationary Period Proposal, Willful Disobedience - AB 430, and Budget.

The next meeting will be Friday, May 4 at the Sacramento Office/ Web Ex.

Middle Grades Education Council

▶ The Middle Grades Council met Thursday, March 8 in Sacramento. A presentation of the California School Dashboard was made. Questions were asked about how to use it to have valid, forward moving conversations with staff. Looking at the distance from 3 was stressed. The Dashboard is for an overall discussion with community members, staff and stakeholders. Demographics re-

ports are used to work with sub-groups. The following questions were asked and will be taken back for clarification and further exploration.

- What is the definition of chronic absenteeism?
- Will participation rate and other indicators be updated?
- Can Social Emotional be addressed through the Dashboard information?

Best practices were shared regarding SBAC preparation and positive spins on the process to help the students be less stressed and take the tests seriously. Many great ideas were given to help students succeed.

Laura Preston presented information about various bills in the process of being introduced and formulated, including cannabis, teacher miss-assignments, tenure, and increased time allowed for substitutes to be in a classroom.

Educational Options spoke regarding the programs designed to "break the cycle."

There was some discussion about brain maturation.

We discussed topics for the November Leadership Assembly.

Trauma informed classroom management was a hot topic.

This was an excellent meeting with lots of sharing and excitement about the future of education.

We are looking for ways to be sure every middle school administrator can be informed about the content of each Middle Grades Council meeting.

▶ Conversations and discussions during Superintendent Council meetings this year have centered upon the future of school funding legal / legislative updates, and educational trends impacting us all.

The ACSA Governmental Relations staff provided an overview of the findings from a study regarding the future of LCFF. Both quantitative and qualitative information was obtained from approximately 200 superintendents from across the state. The key findings from research included the following:

- The need for a higher LCFF base funding grant
- The restraint from creating new categorical programs
- The impact of Pension and Special Education costs

The Superintendency Council has engaged in conversations with Deputy Counsel for State Board of Education, in providing input on the development of the state's system of support. The superintendents have stressed the need for resources and staying away from compliance focused activities.

The council has also held many discussions on the professional needs or trends in education, and how ACSA can support and move forward in these areas:

- 1) Funding and finance
- 2) Teacher Shortage
- 3) STRS and PERS Increases
- 4) Sustainability of Instructional Technology
- 5) Social Emotional Vulnerability of Students

At our recent Recruiters and Ambassadors Meeting, Margie Cuizon, State ACSA Senior Director, Member Services and Support, shared that their goal for 2017-2018 is 300 new members. She said the current retention rate is 89% once a member joins. The big concern for this year is the loss of 600 members from San Diego Unified. Because of budget issues, that district no longer pays dues for their administrators. Cuizon also explained the various membership dues options that are available.

The attendees were divided into groups and asked to address the following:

What are the barriers to recruiting?

Some of the barriers listed include:

- Cost for young administrators
- Superintendents not supportive
- Job pressures – too much on their plate
- Not getting new member names from HR
- Competing with costs for a clear admin credential
- Cost of Academies
- Lack of knowledge of membership benefits

What are solutions to the problems?

- Offer dual membership – transition plan – tiered levels for new administrators
- Tier membership fees while getting clear credential
- Need more one-to-one contact
- Ask new administrators what they expect of ACSA
- Need more support from districts
- Grow Ambassador and Recruiter numbers
- Region programs to invite new members to become active

- Regions form committees and communication between membership chairs, recruiters, and ambassadors
- Outreach to superintendent

Staff provided a tour of the ACSA website and several suggestions were made to improve access and usability.

There was a review of the Mentor Program and some of those in attendance described what was happening in their regions/charters. We were told that regional facilitators communicate with all applicants and match protégés with qualified mentors. It was suggested that this process be shared with leaders across the state.

Midyear recruitment winners — Penny Fraumeni, Charlene Lemons-Shivers and Ann Kitty — were announced.

Information about ACSA's Targeted Assistance Program was shared. The program focuses on providing direct support for school district superintendents in three key areas: Effective board-superintendent relations, labor relations/negotiations, and school bonds/facilities.
