From Joell Hanson: Sustainability of funding is different than grant management...LCFF versus grant. Maybe pull in LCAP with CCI that would encompass sustainability and funding?

From Claire Grissom: Should we narrow the focus on what we can get done in one year? SMART goals? (Ex: Waive the waiver fee for a CTE credential.)

From Joe Austin: I don't disagree with the ridiculous \$100 waiver, but I think our bigger challenge is our LEAs inability to place CTE teachers coming from industry onto our teacher salary scale with a reasonable number of years of experience (relative to what they bring from industry). Let's start with a presentation to the ACSA state board, Leg Policy too.

From Julie Duncan: Joe absolutely! That is why many ROP's salary schedules are not like standard teacher salary schedules. We count industry experience. I know it is more difficult with a salary schedule that includes all high school teachers.

From Ebon Brown: Joe, in Beaumont we developed a CTE teacher salary schedule that counts years of industry experience. It also takes into account Industry Certificates into salary placement. It compares side by side with our standard teacher salary schedule. I can send it to you if you want.

2022-2023 CTE Council Goals will remain the same as the 2021-22 goals with an adjustment to the grant streamline goal. That goal will adjust to "sustain" and "increase with current economic

		climate". The last time the by-laws were viewed and adjusted was in 2010. Recommendation is to review the previous CTE council annual plan in order to update and align council goals. Naj and Lisa are going to work offline to align our goals with the ACSA strategic plan Lisa will report back to the council on what we say our work is and what we are doing.
