12:00-12:15	Legislative Updates <u>Serette Kaminski</u>	 AB 377 Assembly Education tomorrow - No registered opposition - Until May 19th if it is tagged Fiscal Intent to reduce administrative burdens by consolidating CTEIG and SWP and provide Technical Assistance at the local level Budget sub-committee hearings also taking place alongside the legislative session. There was a discussion regarding funding under AB377 and a couple of issues that need to be addressed. Kelley brought up a gap in funding for COEs to provide direct support, above and beyond TA. The match drop may not answer all of the funding questions and the formula needs to be reviewed so there are not funds left after allocations.
