DIVISION News

- The new Perkins Plan was approved by the feds in August.
- California Workforce Joint Advisory Meeting (CWPJAC) next meeting is November 20, 2020. Agenda item includes CTEIG and K-12 SWP data collection and metrics.

Career Technical Education Leadership Office

PPE

 PPE was ordered for ROCPs and Adult Education sites that responded to a survey in September. The CDE has worked in collaboration with Cal OES to provide PPE to the ROCPs and Adult Education sites who were not included in the first order of PPE. The PPE ordered is currently being delivered and will flow through County Offices as the distribution point and will be specifically marked and delivered to the ROCPs and Adult Education sites that made the request.

CTEIG

- FY 20-21 allocations will be announced during the January 2021 State Board of Education Meeting.
- Expenditure reports will be out to the field shortly. All LEAs who have received CTEIG between the years of 2016 and 2019 are required to report by January 31, 2021. Final expenditures for 2016-17 and 2018-19 must be submitted. Expenditures for these years may go into January 2021 as long as they are reflected in the final report that is submitted by January 31, 2021.

Perkins

- Perkins applications are due and must be completed by December 30, 2020.
- Perkins GANs have been distributed to all applicants who filled out a "Delay Assurance" though many have taken advantage of the flexibility it offered to get extra time on a particular section of the application, to redo their Stakeholder Engagement meeting. FPMs for CTE continue as usual, with the exception that all in-person reviews have been changed to online reviews, with meetings via Zoom replacing in-person and on-site. In person reviews will be revisited due to COVID-19

CTSOs

• It's affiliation time for all CTSOs and Perkins and CTEIG funds may be used to support these efforts. We have had reports that some LEAs are choosing to only pay for competitive students and this goes against everything that CDE and

CTSOs stand for. CTSOs are to be student leadership focused first and competitions second.

Work Permits

- The Governor signed AB 908 which will have a marked impact on the state's work permit program

- Districts will no longer have discretion to deny work permits to students with bad grades and/or attendance problems during the pandemic.
- Districts will need to monitor the well-being and health of working students
- The permit process will be allowed to move to the internet, (with electronic signatures) and presents the possibility of a district exposing student **Personally Identifiable Information**
- There may be a need to plan on maintaining a physical work permit system to accommodate students and families who do not have access to technology
