ACSA Board of Directors meeting:

Consent items:

• The ACSA Board of Directors approved the following consent items: minutes from the February 18, 2022 governance meeting; the ACSA membership report as of March 31, 2022; the ACSA Employee 401(k) Retirement Plan Annual Report; the financial statements for the nine months ending March 31, 2022; Change of Committee Purpose for FY2022-2023; New State Council Presidents and State Committee Chairs; new ACSA Board of Director for Regions 2 and 5; FY2022-2023 Board of Directors for ACSA.

Presentations:

- The ACSA Board of Directors received a Committee Chair/Council President End of Term report from Kathleen McCreery, Chair of the ACSA Retirement Committee.
- The ACSA Board of Directors received a presentation from Dr. Adam Clark, superintendent of Mount Diablo Unified School District, on strategic and collaborative efforts with CAAASA.
- The ACSA Board of Directors heard remarks from incoming ACSA Executive Director Dr. Edgar Zazueta. Some of the highlights of these remarks included:
 - During the first 90 days, one of the top priorities will be implementing a performance evaluation system. Zazueta is currently working with Marjorie Burghgraef, ACSA Senior Director of Human Resources, to bring in resources.
 - The ACSA Board of Directors will be receiving an update (in addition to a normal board report) from the executive director at least every other week.
 - Edgar's first official day as ACSA's Executive Director will be spent in Perris, where he attended school.

• The ACSA Board of Directors tabled the debrief of the May 2022 Leadership Assembly due to a low survey/evaluation response rate from participants.

Proposed Budget: FY 2022-2023

• The ACSA Board of Directors approved the proposed budget for ACSA Entities for Fiscal Year 2022-2023. Highlights of the approved budget include:

- The FY23 budget for ACSA, FEA, and SASS is presented with a surplus on a combined basis.
- ACSA membership revenue is slightly up compared to the 2021-2022 Fiscal Year revised budget.
- ACSA Region rebates will remain at 15 percent of membership dues.
- ACSA staff will receive a four percent Cost of Living Adjustment and the organization will add five staff positions.
- Rental income is expected to remain flat.
