### CTEIG – Round 7A

- Two-thirds of the GANs have returned
- Funds have started going out about half of the funding
- Will continue to release funds on a weekly basis

### CTEIG - Round 7B

- Preliminary allocations to be presented to State Board on May 18
- GANs have all been approved and ready to go out as soon as allocations are approved

- 2022 Expenditure Reports were due January 31, 2022. It is the final report for 2017-18 and 2019-20 and an interim report for 2020-21. If you did not submit a report and/or spend each allocation, CDE will be sending LEA(s) an invoice for unused CTEIG funds. - 2022-23 CTEIG RFA planned release for Fall of 2022 due to the pending legislative change to CTEIG/K-12 SWP in AB 2058.

# CDE Legislation Updates

### Legislation

- AB 2058 Boosting CTEIG to \$450,000,000, K-12 SWP language repealed; Will delay the CTEIG 2022-23 application until September.
- Golden Pathways, \$1.5 billion and Dual Enrollment, \$500 million, extended to run through 2030.
- AB 2088 CTE paid student internships; \$575 million over three years; \$14 per hour ½ from grant, other from employer. This is being discussed to be included in the Golden Pathways language over 5 years.

## CDE Legislation Updates

- AB 1923 STEM CA Partnership Academies.
- SB 830 ADA to ADM (average daily membership)
- Proposition 51 \$1.4 billion to support school construction projects (May Revise)

Most bills that will have an effect on CTE have been reviewed by our division and are still up for consideration. There has been nothing definitive yet.
