- I. This is the first of three in-person VPLA meetings. Next in Sac at Leg. Action Day in April and 3rd in May, location TBD. Virtual meetings will happen throughout the year.
- II. Ivan Carrillo, ACSA Director of Legislative Action gives summary of advocacy results last year (see flyer).
- III. Gina Potter, State VPLA, stressed we need to be aware that state revenues are down and it could result in \$267 less per ADA due to Prop 98. Be careful with negotiations and don't spend special grant funds unless you need to in case you need them in the spring.
- IV. Discussion about the need to increase the teacher and admin preparation pipeline as well as more flexibility in credentialing. We also talked about the difficulty of many districts, especially small districts, to provide universal meals, transportation and ELOP due to staffing shortages and contract issues.
- V. Local Legislative Advocacy Meetings: How can we do advocacy in November and December? Our April Advocacy Day is well after the governor's Jan. budget proposal. How can we get our word in before that? -One idea was to ask supts/school boards to contact legislators. Arrange regional/local ACSA members to request meetings. Invite legislators to a school or school event.
