Diaan reviewed appropriation from Washington- Johnson/Schumer reached a deal. Most programs are forward-funded except Head Start.

P3-Credential Update

Tandy:

June: Has been part of a task force of a workgroup that created an ECE performance evaluation development to be used in the college.

The Assistant Superintendent needs to be added to the workgroup to collaborate with Early Education groups outside UPK so change can happen. Working on Mental Health, Power 2424, will help in coping with change in early childhood education.

Laurell- Region 14, Grateful for ASCA, under-enrollment, and workforce lack of staff (2 teachers) How to attract teachers. Headstart California is working on an Associate Permit; many are leaving the field because they do not want to go back to school.

Heidi Nunes, Region 7, is experiencing similar issues regarding staffing for ECE classrooms and lower enrollment due to expansion of TK. Families have shared they want a longer day that mirrors school days. Many CSPP and Head Start teachers are taking advantage of the EETDG and going back to school to earn their Multiple Subject Credential. Attended developmentally appropriate toileting practices- had beneficial resources Toolkit

Community need for school day CSPP

Darcy-Region 12, staffing has been difficult. large number of teachers going back to school for multiple subject credential. Working on a pathway to train aides to be teachers. Toileting challenges for TK, collective bargaining happening. Working on developmentally appropriate

Carmen-Region 19, Preschool consortium has been meeting bringing TK together as part of UPK. Seem to be coming together with a common focus. Districts are connecting together to support enrollment/place students in programs.
