#### **State Legislature Endorsement Process**

A team of ACSA leaders have been meeting with candidates for local state legislature races in advance of the March primary. State ACSA divides the races among the regions. Our job as a region is to recommend candidates to the State ACSA Board for its final determination of endorsement. In many cases, a recommendation or final decision to *not endorse* is also made, for a variety of reasons.

Senate District 15 (currently Jim Beall's district) and Assembly District 25 (currently Kansen Chu's district) are the two open seats that have been assigned to our region. We will be forwarding recommendations about these races along with recommendations for three uncontested races in districts with incumbents running for reelection, Assembly District 24 (Marc Berman), Assembly District 27 (Ash Kalra), and Assembly District 28 (Evan Low).

# **COUNCIL/COMMITTEE REPORTS**

# **Superintendents Council**

## **Shelly Viramontez**

The meeting was held in Sacramento on October 30, 2019. We had a presentation from Megan Macy of Lozano Smith on AB 1505 – Charter Reform Bill. There is a toolkit

that can be obtained on the Lozano Smith website. It addresses the changes in approval criteria and appeal process. We also discussed the ACSA Strategic Plan's 3 areas of: Member Development & Support, Advocacy & Influence and Organizational Development and Stability. You can share your needs with ACSA through the button on the ACSA webpage and app, click and tel them what you need them to work on.

Tom Aremilino of CCEE discussed the 21<sup>st</sup> Century California School Leadership Academy (CSLA) to support teams and development. New State Board member, Linda Darling Hammond is a big supporter of this.

We had a report from California Department of Education - Lupita Cortez Alcala, Chief Deputy Superintendent. She shared the desire from the State Supt and the Governor to have schools stay open that are not in eminent danger. While 291 school closed because of the Kincaid Fires, another 421 closed because of the Public Safety Power Shutoffs (PSPS). We shared what schools need to remain open: Generators, Clean Water, Running Toilets and the Ability to Communicate. CDE is looking to collect data around building resources to shelter in case of emergencies

Edgar Zazueta shared an update of Full and Fair Funding. The 2020 initiative sponsored by ACSA and CSBA. It is polling well and if it passes in November will result in an additional \$15M per year for CA public schools. They also discussed AB 48 Facilities Bond, which is a mixed bag for districts ability to collect developer fees. The Legislators and the governor have been busy, the Governor Newsom signed 1,169 Bills and Vetoed 172. It is estimated that it will cost schools approximately \$1.5B to implement the various legislation. In the budget update, it was shared that we are likely to be in a COLA only funding unless we get Full Fair Funding passed. Challenges of hiring enough bus drivers, special educators and substitutes was also shared. We also discussed the need for advocacy for containing the costs of Special Education, with the suggestion that we work on an amendment requiring districts to only pay for the percentage of parents' attorneys based on findings. For instance, currently if there are 10 allegations and the parent prevail on one, the district must pay for all of the attorney fees. We would like for the district to only be responsible proportionally, so in this instance, the district would pay one tenth of the parents' attorney fees.
