#### **REGION XI CONDUCTS ANNUAL PLANNING SESSION IN BAKERSFIELD**



Dr. Blanca Cavazos, Region XI President, chaired the 2014 Region XI Annual Planning Retreat held at the Marriott Hotel in Bakersfield in June.

The kick-off activity of the 2014 Annual Planning Session was an Executive Board meeting composed of Region XI Officers. It was held at the conference room of the Kern County Office of Education under the leadership of Dr. Blanca Cavazos, 2014-2015 Region XI President.

Dr. Ralph Porras, State ACSA Vice President, met with the eight members of the Executive Board. Business conducted at the meeting included the following:

- 1. Discussed Executive Board Responsibilities
- 2. Review of ACSA Strategic Plan
- 3. Establish Region XI goals for 2014-2015
- 4. Developed a calendar of Region XI events for 2014-2015
- 5. Recommended a budget of \$81,664.00 for 2014-2015
- 6. Heard a status report on Region XI conference by Jana Freeman, Region XI Vice President.

The planning session continued its business on June 17 at the Marriott Hotel in Bakersfield. Porras attended the morning session and commented: "As you go back to your charters, encourage your members to be actively involved."

A review and discussion on various Board Members responsibilities was conducted by Dr. Cavazos, Region XI President and Dr. Christine Frazier, Kern County Superintendent of Schools and former Region XI President and State ACSA Board Member.

Each of the major agenda topics of the previous day's Executive Board Meetings were shared with various recommendations. Other updates were given which included:

- State retirement report by Bill Black
- ACSA's Financial Plan for FY 2014-2015 by Dr. John Snavely
- Legislative Action by Tom Addington
- Fall Conference by Jana Freeman. There will be no Region XI Conference scheduled for 2014-2015.
- Region and Charter Membership by Dave Tonini and Jeff Vandernoor
- Region Newsletter and Handbook by Dick Schlagel

Dr. Cavazos had members in attendance participating and sharing various topics throughout the planning session. Maintaining ACSA's visibility is a major goal at all levels, local Districts, Charters, Region and State.

Region XI will be seeking ways it can be recognized at the State ACSA level during 2014-2105. EDCAL will be receiving information on transitions, best practices, etc. from the local charters, Region XI and the newsletter editor.

Region XI will continue to focus on membership. Vandernoor, Region XI Membership Services Representative, reported a current membership of 933. The importance of having an outstanding Planning Conference with good attendance was shared by both Tonini and Cavazos. The Region Retreat has been allocated \$10,000, up from this year's \$3,000, for next year's event.

Next year's planning retreat has been scheduled for June 15-16, 2015. The location and specific times are still to be determined.

#### KINGS CHARTER SPONSORS 42nd ANNUAL FALL CONFERENCE

Dr. Marc Johnson, retired superintendent, Sanger Unified School District, and currently serving at Fresno State University, was the keynote speaker at Kings Charter 42nd Annual Fall Conference.

Johnson's remarks through his presentation focused on "Everyday Heroes."

"School administrators and teachers need to be effective problem solvers, communicators, and collaborators," Johnson said in his opening comments.

He shared a quote credited to Fred Douglas: "It is easier to build a strong child than to repair a broken man."

Johnson asked the administrators, what is your role in winning and how do we define winning?

"Every kid crosses home plate. We are not to leave any kid on first base," Johnson said. "all kids must cross home plate. What does your school, district, teacher guarantee for each child?"

"Clarity precedes competence." Johnson said. "We must have goals and initiatives that focus on (1) raise all student achievement, (2) close the achievement gap between sub groups and (3) ensure a safe school environment."

He emphasized the power of Professional learning communities and that we learn together. We must have a mission, vision, values and goals.

"We must have a good first teaching. That is vital," Johnson said. "Essential standards must be determined and they need to be understood."

#### Johnson shared three guiding principles:

- Hope is not a strategy.
- Don't blame the kids.
- It is about the student learning.

He reminded attendees that "we are the only hope some kids have."

He closed his presentation with the following remark: "The first and most important truth about a leader is that you make a difference. Be the light."

This year's conference featured two breakout sessions, each with nine workshop presentations. Johnson presented back to back workshops on "Elementary Principal Job Alike."

13 Vendors were in attendance sharing information on their various educational products, resources and

programs throughout the conference.

A delicious buffet dinner preceded Johnson's presentation in the beautiful gym at Pioneer Middle School in Hanford. The FAST Credit Union was a major business sponsor. Jennifer Solis, FAST Marketing Director, chaired the drawing of a vast array of gifts given to conference participants. Administrators were very positive with their remarks pertaining to this year's conference.

"This is an outstanding event with wonderful and informative Break-Out Sessions," Bill Fishbough, Superintendent, Hanford High School District said.

Cheryl Silva, Assistant Superintendent, Hanford High School added: "It was a very organized event. Workshops were both informative and relevant. Good food."

#### TULARE COUNTY'S ANNUAL SUMMER INSTITUTE FEATURES JIM NABER

"Leading Your Team to Victory" was the theme of the 2014 Summer Institute sponsored by the Tulare County Office of Education, Jim Vidak, Superintendent, and Tulare County Charter ACSA, Lora Haston, President.

Approximately 230 school administrators in Tulare County were in attendance to hear the keynote address delivered by Jim Naber, Olympic Champion Swimmer, Network television and radio sports broadcaster, author and corporate speaker.

"Olympic champions are ordinary individuals who accomplished and get extraordinary results," Jim Naber said in his opening remarks. "They are ordinary people who have found extraordinary ways to be winners."

"There is no limit to what you can achieve," Naber said. "If you feed your desire, eventually your desire will feed you." Naber shared comments about a variety of Olympic champions who are winners. He encouraged administrators to create leaders on their teams. He outlined eight key factors for a successful leadership team. They include:

- Desire . . . "have a dream"
- Faith . . . ability to believe in yourself, believe it is possible. Power, passion, desire - is it possible?
- Goal . . . Set goals, seek results that are workable.
- Have and create a plan/strategy for reaching your goals and results.
- Know how to get where you want to go. Slice it up in very small sections. Establish "stepping stones."
- Hard work...The will to prepare to win is critical.
   "No deposit, no return."
- Will Power . . . What happens to you when things go bad? How do you react to adversity? What plans do you have to handle it?
- Performance under pressure . . . Encourage and display courage, have that ability to be our best when it really matters.

Naber concluded his keynote address by stating: "If you want to lead your team to victory, you must display and apply courage."

Conference attendees had opportunities to choose twoone hour breakout sessions. Morning workshops available included:

Responding to disruptions of instructional and school activities, providing a safe school supportive environment, Cal STRS Basics, a lens for understanding classroom instruction and assessment and linked learning.

There were four afternoon sessions which included two not scheduled in the morning. Employee discipline: Administrator and supervisor responsibility and a suicide safer community.

Following a delicious buffet lunch and entertainment by the TCOE theatre company, Brian Roberts, Director and students, Kaley McConnaghey and Laurean Adaska. Tulare County Charter ACSA honored and recognized 18 outstanding administrators of the year. Ten High School Seniors were also the recipients of scholarships awarded by ACSA. 16 vendors provided a vast array of door prizes which were presented at the conclusion of the institute.


 Terry Wolfe will once again chair the Annual Golf Tournament. Last year this event brought in \$6,500 to be used for student scholarships.
