INTERVIEW WITH DR. CRAIG WHEATON

Dr. Wheaton is currently serving as Superintendent of Visalia Unified School District. He will be changing positions in February 2016 as he joins the Tulare County Office of Education Administration Team. Dr. Wheaton is a candidate for the State ACSA Vice President.



1) What has been your training and administrative experience?

I have had to privilege and honor to serve as Superintendent for Visalia Unified for the last six years. My administrative training took place in a small district In Kings County and I am very fortunate to have had an opportunity to gain a wide range of experiences. Continuation high school administrator, High School Assistant Principal, and elementary principal are just a few examples. I have to credit ACSA for providing excellent staff development opportunities and I have taken advantage of those throughout the years. Everything from serving the Charter to Academies have been extremely valuable to me.

2) What has been your most rewarding and enjoyable part about your position as district superintendent?

Serving as superintendent is both rewarding and challenging. I do consider my role as one who serves others and I don't consider what I do as a job. I am fortunate to have the opportunity to apply my skills and training as I provide support for teachers and administrators. I enjoy the day to day challenges that come with the job. My favorite part is really to spend time at schools, in classrooms, and at student events. That is what we are all about – students – and maintaining close contact is the best part of the job. And as a superintendent of a district with 40 schools, it is important to maintain that close connection to students and not to get lost in the day to day demands of the job. What is your most enjoyable free time activity: Anyone who knows me will know that I love the outdoors, especially running! " Run Craig Run" isn't just a slogan for my ACSA VP Campaign, it is how I live my life. We are in the "Futures Business," helping our kids develop the skills they need so that they can pursue life success at anything they want. This is important but highly stressful work and having an active life outside of the job is necessary to keep a balance in life. Running is that balance for me.

3) What have been your leadership services and responsibilities with ACSA at the local charter, region, and state levels?

I'm not sure where to start. First, I'd like to encourage every administrator to serve in some role in ACSA. It is a great organization and I have found that I have gained so much out of my service maybe even more than I have contributed. Over the years I served in every office in Kings Charter, Vice President through Past President. Similarly I spent years on the Region 11 Board and held all the offices including President. Over the last few years I have been active at all levels, Tulare Charter, Region 11, and State ACSA. I spent 12 years on the state Curriculum, Instruction, and Accountability Council representing Region 11 for one term and then serving as Vice President and President of the council. More recently I spent one term on the Superintendency Council and I am in my second year as the Region 11 State Board director. Additionally, I have directed several Academies including the Curriculum and Instruction Academy, LCAP Academy and served on TICAL.

4) Why do you want to seek the office of State ACSA Vice President?

It would be a great honor for me to serve as a state officer. I believe the experience I have accumulated over my 37 years as an educator and my 30 years as an ACSA member puts me in the position to give back to the profession and to ACSA. This is a pivotal time in education and administrative leadership is most important to ensure our kids have the necessary educational opportunities to be successful. I have grand children in our school system and I believe I can contribute by taking on a leadership role in ACSA. My main goals are to focus on student needs by ensuring our educational leaders have the support necessary to meet the challenges before us. New standards, a changing world, providing equity and access are all challenges and opportunities. I can be part of that leadership as ACSA assumes a lead role in representing administrators for the benefit of students.

5) Why Should an Administrator join ACSA?



If we want our students to make academic progress we must give them the instructional time they need without the encroachment of overzealous politicians demand for weeks of testing data.

Recently parents and politicians have weighed in on the issue of too much testing and assessment. What are they talking about? Some of the recent articles and commentary on testing assume that everyone understands the definition of "testing". So, What is the difference between tests, assessments, and diagnosis? Essentially, a test is a tool, an assessment is a process, and a diagnosis is a decision.

Once we clarify what we are doing (testing, assessing or diagnosing) we can look at some very important points to consider in evaluating student performance and progress:

A recent study indicated that less than 2 percent of instruction time is lost to testing.

49% of parents in a poll conducted by the Center for American Progress found that parents believed there is too much testing in schools.

However, three out of four parents believe it is important to regularly test students to determine their academic progress (Associated Press-NORC Center for Public Affairs Research).

2015 ACSA LEADERSHIP SUMMIT: COURAGEOUS LEADERS IGNITE THE DREAMS OF ALL

"We cannot rely on the legislators to right these wrongs." McRae said. "The California Legislature has a poor track record. The law requires students to have equal opportunity. Having an effective teacher is a constitutional right."

The 2015 Summit provided rich learning experiences for administrators across our 19 regions. Now that the Leadership Summit is history, ACSA Educational Services is focusing its attention on more great upcoming professional development opportunities. Administrators had an array of opportunities to attend and participate in a variety of workshop sessions.

Two very special events were the Every Student Succeeding Luncheon and the Presidents awards presentation/dinner dance. Eduard Cardenas, Porterville High School graduate, was Region XI's Every Student Succeeding Award winner. 

EDUARDO CARDENAS RECEIVES REGION XI'S EVERY STUDENT SUCCEEDING AWARD



ACSA's Every Student Succeeding Recognition Program honors students who exceed expectations and also the educators who support them along the way. The state administrators organization is proud to highlight 20 students. These ESS award recipients are extraordinary examples of

perseverance, dedication, maturity and grace.

Region XI's recipient is Eduardo Cardenas, Porterville High School 2015 graduate. The supporting ACSA member is Jose Valdez, Principal, Porterville High School. The support team members are Teresa Zamarripa, Counselor, Michelle Hapapoff, Lead Teacher, PABF Academy and Julie White, CTE Teacher.

In the 10th grade, Eddie Cardenas was burned over 65 percent of his upper body in a barbecue explosion. At the Fresno Community Hospital Burn Unit, he underwent two days of debris removal. On the third day he surprised everyone and got up and walked. But he remained in the hospital for more than seven months and endured 25 surgeries. His mother and father were there every day, and he became an inspiration to other burn patients.

Throughout his ordeal, Eddie managed to keep up with his school work through the Fresno USD Home and Hospital Program. When he returned to Porterville High School for his junior year, he stayed on the A-G track and applied to Fresno State, Fullerton, Monterey and Northridge universities. He plans to pursue a career in physical therapy or a related field where he can help others. Eddie is now healthy and strong, physically and mentally.

JOHN WERNER: A 'BIG DEAL' FOR ADULT ED

One of the areas of education that was most challenged during the recent recession was adult education. Drastic budget cuts threatened the very existence of many adult ed programs.

But adult education is a key factor in helping older students become employable, tax-paying citizens. That's why it's so important to have an educator like John Werner, assistant principal of Visalia Adult School, who has been named ACSA's 2015 Adult Education Administrator of the Year.

Like so many who enter the world of school administration, Werner wanted to take his passion for educating students to new levels and have an impact beyond his classroom.

"It has been a great move," Werner said. "Education is a rewarding career because we're afforded the opportunity to help others reach their dreams. Education has elevated my life and provided me with wonderful opportunities. It has equipped me to do better, and I want others to experience that. I want others to experience the success and joy I have had in my life because of a great education. That is why I became an administrator, to help others stretch their horizons and reach out for something better."

In the brave new world of adult education, consortiums with higher education are key. To that end, Werner is an active participant in the Sequoias Adult Education Consortium, and chairs two of its subcommittees: Student Acceleration and Professional Development. In addition, he coordinates with the Tulare County Sheriff's Office to provide high school equivalency to inmates, and helped in their implementation of online GED testing. "We are in the process of defining adult education's role, where it still exists, in regional economic growth," Werner said. "Our funding seems to be getting stabilized, but that comes with new definitions of service and criteria for performance."

Werner said it is important to look for the opportunities in new challenges.

"We need to be creative and vocal. If you ask me, we are actually in a great position to influence law and define adult education for decades to come," he said.

Despite his hard work, Werner was humbled by this award, an honor he does not take lightly. "There are scores of adult education administrators working hard in a very uncertain landscape around the state," he said. "Their work and contributions remind me there is always more I could be doing. We all stand on the shoulders of giants."

Werner said he has been struck by the fact that such a "big deal" is being made about the recognition.

"I suppose it is kind of a big deal." He said. "But I have to tell you what is a bigger deal. A bigger deal is the impact that adult education makes on the lives of its students. We help the single moms trying to get off welfare gain some pride when they get that diploma and land their first job. That's a big deal. A big deal is when a parent is able to help their struggling child with math homework for the first time because of what they learned in an adult ed class and not say, 'Honey, I don't know how.' When the embarrassment is erased for them. That is a big deal."

"As a daddy myself with three little kids, I know that is a big deal," he said. "So the big deal going around isn't what I have done, it is what adult education is doing to better the lives of those around us. The big deal is the importance of our adult education programs to a population who needs it desperately. That is the big deal."

Kathleen Green-Martins' strong commitment to critical thinking, creativity, collaboration and communication have been key to her success as project coordinator for the Tulare County Office of Education.

Originally hired in 2007 as a data analyst/grant assistant to help with implementation of the federal Partnership in Character Education program, Green-Martins has grown to be an integral part of the Character Counts office, applying her previous business and computer skills experience.

Her exemplary work in training students, parents, teachers administrators and community members for the enhancement of positive school climate and culture contributed to her selection as the 2015 Confidential Employee of the Year.

As project coordinator, Green-Martins is responsible for promoting programs that are vital to the increased success of students, schools and communities, supporting both Tulare County schools and the California County Superintendents Educational Services Association Region 7, encompassing Fresno, Kings, Madera, Mariposa, Merced and Tulare counties.

"From a young age, I saw myself as someone who would make a difference in my workplace as a productive team member and leader," she said. "Along the journey in the education arena, I continue to aspire to achieve this goal in all my current and future pursuits. Becoming an administrator is a wonderful way to positively touch the lives of others, to make a meaningful difference, and potentially develop others to be leaders within our society." Her work includes continual development and implementation of the statewide Student Mental Health Initiative, safe school training, Positive Behavior Interventions and Support, Reduction and Elimination of Stigma Through Art Targeted Education (RESTATE) Program, and the Choices Prevention Programs.

"The Choices Prevention Programs work with students, teachers and administrators to build protective influences and resources that promote student development (and) buffer risk factors that might otherwise compromise their personal and academic development," Green-Martins said.

She described her tenure at TCOE as having been "full of small and large accomplishments." As an example, she sites the annual Character Counts Week celebration, which has grown from approximately 4,000 students to nearly 10,000 students in eight years.

Working with such programs as Character Counts and Choices Prevention Programs continues to give Green-Martins opportunities to show her ability to manage multiple projects and demands. Regionally, she supports multiple school districts and county offices of education, acting as a conduit to much-needed resources, support, training and technical assistance. Locally, she works with county schools to create annual implementation plans, and assists in annual evaluations of progress and goals.

Through her work, schools and districts are achieving expanded opportunities to receive federal, state and local funding for future stainability, making a measurable difference.

From assisting with events such as the Festival of Hope and Red Ribbon Week Celebration, to staffing a Character Counts booth, to helping to organize a regional student film festival, to coordinating the Drug-Free Communities federal grant, Green-Martins is all about finding ways to collaborate and get the job done.

She said she owes thanks in particular to the leadership of Tulare County Superintendent of Schools Jim Vidak, an ACSA founder.

"The recognition as the state ACSA winner is a truly humbling achievement," she said. "I feel that my accomplishments at TCOE are a direct relationship to the leadership we experience from Jim Vidak."
