1.0 Call to Order

Mauricio reminded the members about ACSA's education legal support fund which districts may buy in to based on ADA.

6.3 State ACSA Board Director – Barry Kayrell

Barry Kayrell shared direct communication from State ACSA including information about a meeting held with Tom Torlakson regarding the new administrative services credential. ACSA has also met with Education Coalition partner CTA. ACSA was represented on the retirement pension advocacy committee. The PAC board will look at the initiatives that are going to be on the ballot and will vote on each item regarding whether the association will support the measures or not. During the past year, each professional development activity sponsored by ACSA has increased in enrollment, including the annual summit.

6.5 Vice President, Legislative Action – Kiela Bonelli

Kiela Bonelli shared that planning continues for the Legislative Action Day being held in April. Letters have gone out to schedule meetings with legislators.
