What was the major focus of the meeting?

- 3. Report from Rich Malfatti
 - a. Leadership Summit, November 6-8th, San Diego—Region 13 sponsors up to 20 people to attend, about 9 committee/council meetings are scheduled to meet the day prior.
 - ACSA staff has some availability to come to Regional meetings to update on current topics: CCSS/SBAC, LCAP, leg policy, credentialing, etc.
 - c. Negotiations workshop opportunities:

- Committee President, Aida Buena, is working on the Superintendent Symposium Planning Committee and will push to have a strand for small schools
- 5. Discussed Hot Topics
 - a. Axiom public records requests coming into districts
 - b. Concern about rapidly changing demographics: increase/decrease in population, falling out of Basic Aide, etc. Lack of planning time to adjust to rapid changes, strain on facilities, resources, reserve, etc.
 - c. Small schools serving special education students with high needs/expensive services -may bring about a qualified budget.
 - d. MAA new procedures and limited staff in SSD to complete the required paperwork
 - e. Provision 2 Schools-must send out survey every four years
 - f. Discussed questions/concerns about SBAC and impact on the new scoring system.
- 6. ACSA Updates
 - a. Legislative Updates—Pension Law and Retirement (Sal Villasenor)
 - i. Pension Law and Retirement changes will have a large impact on districts. Employers rate will take the greatest hit.

Employee rates cannot go up more than 2%/year, and State's rate will increase to 4.6% and this will occur over 3 years.

- b. Legislative updates—Budget (Adonai Mack)
 - i. Budget update—450 million for CC implementation. Pay offs set aside for mandates and most deferrals
 - ii. AB 215—Teacher dismissal bill focused on egregious behavior
 - iii. Vergara Decision—Judge found that it is unconstitutional, being appealed by the Attorney General.
 - iv. June 2015 date to expend CC one times monies
- c. Arthofer)
 - i. Clear Administrative Services Credential Changes
 - 1. Current clear credential pathways to end June 30, 2015
 - 2. New pathway is induction based
 - 3. Extreme need for Certified Leadership Coach for new administrators marthofer@acsa.org
