#### **Kings Charter Sponsors 40th Annual Fall Conference**



Approximately 150 school administratros were in attendance as Kings County Charter ACSA celebrated its 40th Annual Fall Conference. The event with its theme "We Will Survive" was held at the Admiral Akers School on the Lemoore Naval Airstation on September 27, 2012.

in a tour of VFA-122. This year's conference consisted of a vendor fair, six breakout sessions, a keynote speaker, buffet dinner, golden apple awards and concluded with the drawing for an array of raffle prizes.

The conference opened with a vendor fair featuring 12 vendors displaying their products and offering information and various prizes to those visiting their booth.

Administrators were able to attend two workshop sessions which focused on professional development topics, legal issues, and school finance.

Dr. Guadalupe Solis and Laura Gonzalez, administrators, Tulare County Office of Education, presented a session on "Our Journey to the Common Core Standards." They outlined a professional development plan which was used for both administrators and teachers.

This plan includes building awareness, creating resources, tools and training sessions for school personnel. The training program includes tasks, rubrics and various lessons. Other areas addressed were writing skills across the subjects, developing rigorous and meaningful instructional units, a focus on instructional practices, use of technology and acess to sample lessons, tools and video links. "You may contact http://commoncore.tcoe.org for additional information on the Common Core standards," Dr. Solis said.

Gordon Carlson, consultant manager, Data WORKS, presented a professional development session on the "Well Crafted and Powerfully Delivered Common Core Lesson." Carlson was a former administrator in Kings County and a very active ACSA member. He has recently finished his 12th year as a consultant for Data WORKS.

Other workshop sessions available for administrators were: "Update from Sacramento" by Laura Preston, Legislative Advocate, ACSA; Hot Topics in School Finance by John Gray, School Services of California, Legal Issues in Education by Jim Lee and the partnership of school administration and the performing arts presented by Michael Porter, Music Teacher, Admiral Akers School.

The conference's keynote speaker was Justin Bond. He has received a number of medals, both in and out of the Military including the Purple Heart. Bond is currently volunteering for a veterans group called Segs4Vet. He travels the country helping wounded veterans by training and donating segways for them to use as mobility devices. He is also the founder of "Our Heroes' Dreams," a non-profit organization.

He brought propositions 30 and 38 to our attention with comparisons and repercussions being stressed. He also spent some time discussing the Strategic Planning process being facilitated by Bill Cook. Clara Finneran, Region XI East Kern Charter President, is on the Strategic Planning Commission. She did a very nice job familiarizing the board with the strategic plan process. The Delegates broke into groups and discussed the Strategic Planning Commissions guestion: "Is it possible for ACSA to be a hybrid of representative government and the corporation model and/or is there an alternative beyond these concepts that would benefit ACSA?" The results were forwarded to State ACSA for the Planning Commission.

Change is always exciting, whether it is leaves from green to red and gold or the format and function of an impressive organization such as ACSA, it is always rewarding to be a part of the force that drives the change. Region XI is working hard to contact new members as well as veteran members. Our goal is to bring the value of this organization to all members and non-members in our Region. #### **COMMENTS FROM YOUR REGION XI EXECUTIVE DIRECTOR**



A.C.S.A.'s State Delegate Assembly met on October 11. Five delegates from your region represented you with input from charter delegates who attended the Region Delegate Assembly on October 4. The main focus of the State Assembly was A.C.S.A.'s Strategic Plan. We met with the strategic plan's facilitator, Bill Cook, who gave us a status report on the development of the plan and then solicited input from members of the Delegate Assembly. Each Region met with delegates from another region

to respond to the the facilitator's questions and provided input. Bill defined Strategic Planning as a "Means by which a community continuously creates unique and indispensable systems for extraordinary purpose". The hope is that A.C.S.A. will increase its effectiveness as an association in achieving its objectives that will be defined by the strategic plan. Keep up to date on the development of the plan through EDCAL and the A.C.S.A. website. There are no sacred cows and everything is on the table in terms of change to the association.

John A. Perez, the Speaker of the Assembly, spoke to the Delegates about the importance of passing Proposition 30 and the consequences of not passing it. He asked all Delegates to get the word out to state school administrators that their strong voice on this issue is critical. He challenged us to discuss the proposition with friends, family, and stakeholders in our communities.

School suspensions was another hot topic. Representatives from Garfield High School shared their story and how they decreased suspensions at their school. It was apparent that there is a well organized group that is making a strong effort to limit the number of suspensions and expulsions that can be made by a school and district. Your voice on this matter in very important and A.C.S.A. has fought bills limiting the flexibility school administrators now have.

## TULARE COUNTY 2012 SUMMER INSTITUTE FEATURES MIKE RAYBURN



The 2012 Annual Summer Institute Co-Sponsord by the Tulare County Office of Education, Jim Vidak, CountySuperintendent and Tulare County Charter ACSA, Steve Tsubol, President was held at the Edison Energy Education Center in Tulare on June 20, 2012.

Mike Rayburn, Keynote Speaker, Tulare County Summer Institute

Mike Rayburn, worldclass guitarist and stand-up comedian, was this year's keynote speaker. Rayburn's

astounding guitar creations, uproarious songs and presentation skills encourage, inspire and challenge audiences to step beyond their percieved limitations.

"Each of us are more capable than we realize. Each of you have a great potential," Mike Rayburn said in his opening remarks to Tulare County School Administrators. "We need to get beyond our limitations and the major limitation is ourselves," Rayburn said.

He offered a variety of suggestions and advice focusing on "What if I Could?" "Don't look at reasons you can't, look at reasons you can," Rayburn said. "Create ways to meet the challenges."

He offered other advice such as:

We learn by examples. If you face a huge problem, make fun of it as we face it. Step out side of it and find opportunity in the problem. This will draw the best of you.

"Problems become opportunities by looking at the possibilities, by becoming creative," Rayburn said. "We are all creative, but in different ways - ask what if I could? Use creative solutions."

He encouraged the administrators to set goals which

don't exist. Set your dream goals, and impossible goal. "Write it down, commit to it, take action on it right away," Rayburn advised.

His closing remarks focused on administrators to resolve to be the best. Good becomes an enemy of great. Rayburn suggested that they list their ideas on what does it take for me to be the best.

This year's Institute featured seven workshop sessions. Administrators could attend two of them, a morning session and an afternoon one.






