Regional XI's Annual Planning Retreat Sets Goals for 2013-2014

Region XI's Annual Planning Retreat was held on June 17, 2013 at Central Union School District's Board Room located in Lemoore with 22 administrators in attendance.

Tom Addington, Superintendent, Central Union School District and Region XI's 2013-2014 President, conducted the meeting with a wide range of topics on its agenda.

Region XI's leadership team members, under the leadership of Addington, spent much time in discussing and reviewing ACSA's strategic plan. The team decided to have Region XI focus and target three areas for the Region's goals during the 2013-2014 school year.

Goal 1 (Strategy I)

We will be Authoritative Advocates for all matters pertaining to education and its leaders.

- 1) Developing a list of talking points representative of educational concerns for Region XI
- 2) Increasing Participation in Legislative Action (Single day, Multiple Contact and Local Involvement)
- 3) Increasing Connection with Local Representatives
- 4) Influencing the ACSA Voice with Region XI areas of importance

Goal (Strategy II)

We will be the premier provider of an array of compelling learning experiences dedicated to developing the capacity of all education leaders

- 1) Surveying charter strengths, areas of expertise to build network of premier and compelling network opportunities.
- 2) Investigating the ability to co-sponsor with Educational Partners
- 3) Building Resource of workshops/curriculum/training within the Region Website as a repository of information
- 4) Supporting academies/ACSA Training sponsored during the Region XI area during the 2013-14 academic year

Goal (Strategy IV)

We will build and maintain vibrant, purposeful networks of educational communities

- 1) Developing Job Alike Activities
- 2) Considering Board Position at Region XI (Mentoring/ Networking/ Job Alike) Networking Coordinator
- 3) Encouraging local charters to build Mentoring and job alike networking and interaction

Addington led the group in an variety of topics following the goal settings session. He shared the various responsibilities of Region XI Board members. A review of the organization's by laws took place. There is interest in creating a new position for Professional Development.

Region XI's Professional Development opportunities were announced. The Region will be hosting an Innovative Technology Academy at Lemoore and a Principal's Academy at Visalia. The Leadership Summit (ACSA's Annual Conference) is another opportunity for professional development. It will be held in San Jose (November 7-9, 2013)

- Set the Region XI's Budget for 2013-2014 in the amount of \$63,050.00. It will be presented for approval at the September 19, 2013 Region Board Meeting

COMMENTS FROM YOUR REGION XI EXECUTIVE DIRECTOR



Hope your school year is off to a great start and the new state school funding formula is benefiting your district and school. ACSA is your resource if you need questions answered or strategies to follow when negotiating with your bargaining units regarding the additional funds you are receiving.

Two hot topics that your Association is addressing are transgender students and student suspensions. Guidelines are being developed to address how to meet the requirements of the law regarding transgender students. If you have a student or students who are transgender, contact state ACSA for guidance. Regarding student suspension, several civil rights organizations are pushing legislation to limit what students can be suspended for. A particular focus is wilful defiance (K). Their concern is that a disproportionate number of minority students are being suspended for wilful defiance. ACSA is speaking on your behalf regarding this issue and recognizes more training regarding alternatives to suspension for school administrators is one way to address this issue rather than to pass a law that restricts what you need to do to keep your campus safe and keep excellent learning environments in your classrooms. One suggestion is, when suspending students, to not use (K) if you can list another justification for student suspension.

We need your involvement in legislative advocacy. When you receive Legislative Alerts from ACSA, it takes less than 5 minutes

to respond. The letter has already been written for you. There are a couple of places you insert some personal information and comments and then you click send. Your letter is then emailed to you representatives. It is easy and important to do. Many times your representatives just count the letters for and against a bill with little time spent on the content. Your voice counts. ACSA with its 14,000 members can have even more influence on your behalf if all members respond to Legislative Alerts.

Mark your calendar for some important dates:

January 23 - Region Delegate Assembly in Bakersfield- Dr. Marc Ecker, the president of ACSA will be the speaker

April 10 - Region meeting in Bakersfield - Wes Smith, the Executive Director of ACSA is the speaker

All members are invited and encouraged to attend these two Region Assemblies. Contact your Charter President and plan to attend. In many instances car pooling is arranged.

TULARE COUNTY SPONSORS ANNUAL SUMMER INSTITUTE 2013

The Tulare County Office of Education and Tulare County Charter ACSA Co-Sponsored the Annual Summer Institute 2013. This professional Development and Awards event was held at the Edison Energy Education Center in Tulare on June 19, 2013.

Jim Vidak, Tulare County Superintendent of Schools welcomed the administrators.

"We know we have the best students in the state of California, but we also have the best school administrators in California," Vidak said in his opening remarks.

"I appreciate you Jim for your County Office of Education's support and its partnership with our Tulare County Charter ACSA," Frank Silveira, Tulare County Charter President, said as he gave greetings following Vidak's welcome.

This year's theme was: "We're rolling out the red carpet for you!" The red carpet event included a keynote speaker, a morning and afternoon break-out session, a delicious buffet lunch, and lively entertainment. Awards were given to Tulare County Administrators of the year along with student scholarships. Plenty of door prizes were given out at the conclusion of the institute.

Judy Carter, stand-up comic and author, gave the keynote address. "Laughing your way out of stress" was the title of her presentation, she shared some ways and techniques on how school administrators can deal with stress.

"It's not what happens in our life; it is what we do with it," Carter said in her opening remarks. "The best medicine is still laughter," Carter said. "Look for something that went right, not wrong."

She also urged administrators to use positive remarks. "Positive remarks can be powerful. Use the power of appreciation and express it in various ways with different problems and challenges you face," Carter said.

Carter encouraged the administrators to share their story, their life and their message. "You, your story, your journey has a message," Carter, in her closing remarks said, "There

is a small space between you as a victim, and you as a victor, tell your story."

Attendees had a choice to participate in four morning breakout sessions. They included: School Crisis Response: Managing active shooter incidents; The eight most critical expulsion errors; First look at the new state budget and common core mathematics update.

The four afternoon sessions were: School Crisis Response; Health care reform; Health plans overview, fire safety in schools and common core ELA/ELD update.

Following the delicious buffet lunch, Tulare County Charter ACSA presented an array of awards to administrators of the year and 12 student scholarships. The event concluded with the drawing for door prizes. 13 donors donated this year's prizes.

Judy Carter started her career as a magician and later as a stand-up comic, appearing on over one hundred television shows. She was the first woman to play the Close-Up Gallery at Hollywood's Magic Castle. She also formed Comedy Workshop Productions, a school for aspiring comics. She is the author of Standup Comedy and The Comedy Bible. Carter's success in corporate comedy has generated feature stories in The Wall Street Journal, Los Angeles Times, New York Times and Success Magazine. Her pioneering approach to turning "problems into punchlines" has been profiled on CNN, ABC World News and Oprah.

KINGS COUNTY CHARTER SPONSORS 41st ANNUAL FALL CONFERENCE

Approximately 150 school administrators were in attendance at Kings County Charter ACSA as it conducted its 41st Annual Fall Conference. The event with its theme "It's a Jungle Out There" was held at Pioneer Middle School in Hanford on September 26, 2013.

Participants had the opportunity to attend two Breakout Sessions. These various professional development activities included an array of current educational topics: Elementary School Principals Networking, The Brown Act, Kings County Office of Education SARB, Updates on English Language Learners.

Other break out session topics were: What's New in Student Discipline, Common Core-Languages Arts, Curriculum Associates 1-Ready, Cyber Bullying, School Safety, ELD Standards, Employee Free Speech in the Electronic Era and Illuminate Education.

Adonai Mack, Legislative Advocate, State ACSA was the feature speaker and brought the keynote address.

A number of very favorable comments were made by various administrators attending this year's conference:

- They liked the round table discussion (new this year). The content was and should continue to be timely.
- The principal's round table was very informative.
- Continue the legal topics.
- Information about how to align all school district plans for both state and federal monies was very helpful.

Other participants were very positive commenting how helpful the sessions dealing with behavioral supports available to our students and student transgender information.

Greg Henry, Charter President-Elect and Conference Chairperson, shared results of the evaluation survey forms. Areas receiving a very favorable report included Conference Registration Process, Break-Out Presenters Sessions, and Content of the Conference Sessions.

The length of the sessions (45 minutes) received an outstanding ratings with 86% of the participants giving it a "Just About Right" evaluation. Only 14% evaluated the sessions too short and no one rated the sessions too long.

50% of the administrators rated the conference "Excellent" and 23% rated it very good. No attendee evaluated it as "Poor" or "Very Poor." Henry reported that there were nine presenters and 22 vendors for this year's conference.

The Planning session concluded with the awarding of various door prizes.



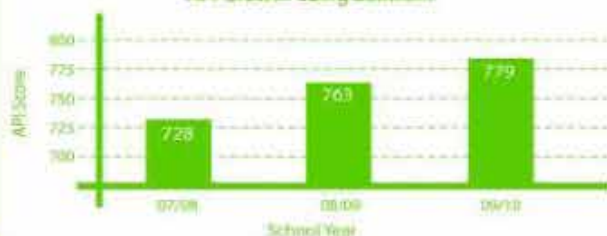

"The time factor and an alternative evacuation site are very important factors," Bell said. "Keeping an up-to-date training program focusing on good communication is very vital for each school site". The Charter's next meeting is scheduled for December 2, 2013.
