

Minutes of the ACSA Region XI Board

I. Welcome/Introductions

- I. Call to Order Blanca Cavazos Dr. Cavazos called the meeting to order at 8:35am.
 - a. Review/Additions/Deletions and Approval of Agenda Motion to approve the agenda was mad by Frank Silveira. The motion was seconded by Mike Tsuboi. The agenda was adopted unanimously.
 - b. Review of Minutes from September Members were given time to review the minutes. Approval of Minutes – Motion to approve the minutes was mad by Donya Wheeler. The motion was seconded by Craig Wheaton. The minutes were unanimously approved.

a. Membership Update

Jeff shared that the last time the Region met; there was a discussion to have a cash drawing for the last 10 new members on the way for the Region to reach 1000 members. Jeff further discussed a prize from the region when reaching 1000 members with the final 10 recruits being eligible for the cash drawing. Jose Morales motioned that *all* new members this year would be eligible for a \$1000 cash drawing if the Region reaches 1000 members *this year*. (regular members only) In addition, if the winning member's dues are paid by a district, the sponsoring district would be reimbursed \$1,000 by ACSA Region XI. The motion was seconded by Lupe Solis. The motion was approved unanimously.

Jose Morales made a second motion that students and retirees joining this year would eligible to participate in a drawing to receive a one year membership contingent upon the Region reaching 1000 members *this year*. Laura seconded. The motion was approved unanimously.

Blanca discussed having Jeff VanderNoor come up with some ways to publicize this recruitment drive.

Elections have come and gone. Jean Fuller, Andy Vidak, Rudy Salas, Shannon Grove, Devin Mathis all won seats in Sacramento. Tom reached out to extend congratulations to each of the candidates and has begun to build and/or rebuild relationships. There will be a phone conference (January 13th or 14th) in planning for Legislative Action Day coming soon. 20 to 25 members are anticipated to participate in Leg. Action from Region XI this year. Craig Wheaton attended the Superintendency Council Breakfast. There are many conversations going on regarding the "One Voice" initiatives. Topics where State ACSA can be united will provide more power legislatively. Superintendents must work together to make certain that their efforts match for the greater good. Terri Reported that ACSA has hit the ground running to make sure language is changed in the rainy day fund legislation to benefit the schools. Terri reminded the group that we must not ignore requests for letters when the time comes.

The Treasurer's report was not completed in time for the meeting. David Tonini reported that we will have over \$100,000 in savings at the end of the month. David Tonini suggested that this extra income be used for the membership in the future. Approval for the Treasurer's Report has been tabled until December.

Don Clark has made a commitment to attend each Region Meeting. He travels over 600 miles to make this happen and must spend the night in Bakersfield. David Tonini recommended reimbursing Don for his travel expenses to Region meetings. Terri Ruffert made a motion to reimburse Don Clark for travel expenses travel and lodging for Region meetings for the remainder of the year to be revisited annually. The motion was seconded by Lupe Solis. The motion was approved unanimously.

David Tonini reminded all Charter Presidents that there needs to be two days scheduled in each charter for legislative action and social networking events. Also, rebates will be upcoming with a 15% rebate along with a small bump of about \$9.00 per member.

There was a request from the Tulare Charter for \$1,000 for the first of two networking socials; one in the fall and one in the spring. One hundred members are expected to attend. With 400 members, Tulare is looking for more ways to get members together in unstructured venues to meet casually and discuss educational trends.

Jana Freeman motioned to provide Tulare Charter with \$1,000 for it's networking socials Laura seconded and the motion was approved unanimously.

The newsletter is up on the website and has 55 photos of members. Dick has assembled a book with 108 total archived newsletters. (Back to 1987) The newsletters were professionally bound and a copy was given as a gift to each Region.

Lupe Solis recommended that this book be archived on the Internet to record the history of Region XI - 1987 and all years forward. He believes the Tulare County Office can help the Region scan and maintain this data.

David Tonini stated that Dick Schlagel produces the finest Region Newsletter in the State. He stated that there are not as many members that read the online version as used to read the hard copy version that was mailed to them. He offered the idea that there be an option to receive the newsletter by mail as well. Jose Morales stated that the same people that would not click the link to the newsletter would likely not read the hard copy either. Tom Addington concurred.

Blanca asked Charter Presidents to take this discussion back to their groups for further discussion to revisit the topic during the December meeting. Jose Morales suggested an "opt in" option for members to actively request copies for those that would prefer a hard copy.

The Human resources council is working on the details of the next institute. They want an award for Negotiator of the Year. They discussed the shortage of subs across the state. Brandman University is working with them to hold a substitute teacher fair as an experiment to help fill the gap. They will get back to us to let us know how it worked.

Business services council met Oct. 23rd. It was suggested that members start thinking about Prop 30 revenue. LCAP revenue will likely not live up to expected funding.

Middle School Committee is looking to have each charter get together with all middle schools in the Region/Charters to build conversation and support.

Equity Achievement and Diversity: There was major discussion on finding balance between home and professional life. There were great speakers at their meeting. Knowing students is the key to success. Foster youth are at very high risk of failing in the system. Statistics were presented to backup this claim. The task brought back to the Region is to find ways to monitor these students and ask questions as to how we are making efforts to bring these students in to find success in our Region. "What are we truly doing to help our subgroups?"

Curriculum and Instruction: ACSA has asked the State to suspend API reporting for the coming year. There is no clear way to compare API with year over year data without a baseline. We as educators have no clear understanding on how we are to be measured, and much of what was promised to school districts have not been delivered.
