## c. Region Newsletter Editor-Notice of Vacancy

Dick Schlagel is in his final year as Region XI editor. The newsletter has gone through its final edit. Copies were distributed and feedback was taken from the Region. This position will change to a Director of Communications position that will entail updating a website as well as publishing news releases. Applications from retired ACSA members must be submitted by March 31, 2016, with a projected start date of May 1, 2016. Dick will work throughout the year to assist in the transition. The equity of pay and workload was discussed, and charters were petitioned to assist more with the work load of the Director of Communications responsibilities. In addition, it was suggested to increase the stipend amount to \$10,000 for the Director of Communications. Val thanked everyone for the feedback and said the executive board would discuss these recommendations. To assist in the recruiting efforts, all retired ACSA members will be emailed and snail mailed. In addition, a posting will be published in Ed-Cal, on the ACSA app, and by word of mouth for applicant recruits.

III. Legislative Action VP Report Tom Addington

Tom Addington was not able to attend due to a prior commitment. Leg action will take place on

April 3,4 in Sacramento and all charters must solidify their attendees.

IV. State Directors' Report

Terri Rufert stated there was no board meeting since Region XI's last meeting, but reported on various updates regarding state issues. The ACSA strategic plan included restructuring its existing look. The executive board has worked to increase ACSA's national presence because of ACSA's involvement through the reauthorization of ESSA. This platform has allowed ACSA recognition at both the state level and national level. ACSA came out as an organization committed to children, advocating for them at the state and national level. Terri also commented on her attendance at the Every Child Counts conference and commented about what a tremendous experience it was for her. The conference exceeded 17,000 participants, with a star group of keynote speakers, and topics of discussion on many educational issues.

A guest from Fresno and Region IX, Mike Berg, attended to discuss a mentor program with ACSA representing Region IX and XI. ACSA launched this mentorship program this year to assist those transitioning to a leadership position in administration in their district or county. The idea behind the mentor program is for ACSA to provide a support mechanism to any administrator who is not the member's immediate supervisor. Volunteer applications are being accepted. Those who are in need of a mentor can request assistance simply through the website ACSA org. Mike is here in a grass roots effort to attend charter meetings to advertise the importance of this resource and its value to their success. Mentors receive a \$200 honorarium for their assistance in this program.

#### b. ACSA State President Report

Tom has been serving children for 33 years and feels fortunate to be here, and in supporting ACSA. Tom has served on the State Board for the last 5 years, and 24 years at the charter level before that. Tom lives in Redding, which is remote and similar geographically to Region XI, and relates to the work that we all do. Tom recognized all of the efforts with those who keep ACSA alive and strong. Tom's experiences with the different people and staff in ACSA have inspired him to take on the roles that he has fulfilled throughout his ACSA career. ACSA has gone through a transition of leadership, and is taking the direction of making bolder moves than their direction has in the past. The focus on ACSA remains advocating for children and ACSA members. ACSA chose not to support a State Superintendent, and has been transparent in why they chose this bold approach. Wes Smith was appointed to a state position by Tom Torlekson as a result of ACSA's bold approach in not supporting his reelection, and Tom has made a concerted effort to be more supportive of ACSA. ACSA also weighed in to be the first organization to support the Vergara lawsuit, weighed in on the pros and cons of publicly

supporting the lawsuit, and chose to move in that direction of filing an Amicus Brief. Former retired leaders volunteered to testify on ACSA's behalf to protect those ACSA members currently in a working capacity, preventing any possible retaliation against them. ACSA is willing to continue to be bold advocates for children, and to be a voice that needs to be heard by policy makers. Tom began an open presentation with our members about his personal experiences, membership, the theme of changing the focus of the Superintendents Conferences to one of learning and meaningful dialogues, and working on a strategic plan that has a profound impact on kids. ACSA took a trip to Washington DC to promote their strategic plan to policy makers. ESSA was reauthorized shortly after the ACSA visit to Washington DC and mirrored many of the talking points verbatim to ACSA. ACSA was approached by NASS, National Association of School Superintendents, to endorse them so that they can have an avenue at the federal level. ACSA is supporting a bill to address the shortage on teachers experienced throughout the state. ACSA advocates for kids!
