Region leadership meets, makes plans for 2018-19

2018-2019 Region XI President Lisa Horne invited region leaders to The Tachi Palace in Lemoore on June 11 and 12 to set plans and goals for the coming year.

On Monday afternoon, the executive board met and had a very productive discussion about board responsibilities, the calendar and budget for the coming year, among other things, in preparation for the Tuesday session, where they were joined by charter presidents, directors and committee/council representatives. That evening attendees enjoyed dinner together.

Incoming charter presidents met on Tuesday morning for an orientation. Horne, Region XI Executive Director David Tonini and President-Elect Matt Diggle went over how to establish a budget, how to set goals, how to access region grants, how to update bylaws, how to submit applications for awards and scholarships, and what each charter's leadership should look like,


Tuesday, with the full array of region leadership in place, Guest Speaker State ACSA President Dr. Holly Edds talked about what is happening at the state level. Highlights included the new strategic plan, which is nearly ready to role out, the new Fatal School Violence Task Force, the new ACSA Resource Hub, the Janus case soon to be decided by the Supreme Court, and the primary election results. "The Governmental Relations team had a 100% success rate in the organization's primary endorsements," she said. "The five candidates who were endorsed are moving on to the general election in November."

Vice President of Leg Action Craig Wheaton led a discussion about what recommendations the region would give to the Governmental Relations team about who to endorse in the general election in November.

Your opportunity to participate in legislative race endorsement process will arrive by email

During the Saturday, May 12 Board of Directors meeting, members received positive feedback on the format of the May Leadership Assembly, including:

- The professional development component and sharing of best practices as an integral part of the meeting.
- The opportunity to contribute feedback on the Strategic Plan.
- The positive and collaborative tone of the meetings.

A discussion was held regarding legislative race endorsements. ACSA Vice Presidents of Legislative Action (VPLA) and Governmental Relations staff evaluated all statewide legislative races in late fall of 2017 and recommended ACSA be involved in 11 key statewide Assembly/Senate races. Once the June primary results have been certified, ACSA will reach out to members by email with a questionnaire to collect input and then decide on endorsements. Responses will be due back in July. Constitutional officer candidate interviews will be held in conjunction with the board retreat which will also be held in July.

The ACSA 2018-2019 budget was approved by a unanimous vote of the board. It is a balanced budget, which maintains reserves and increases the commitment to the Rainy Day Fund. The budget also provides a 1% salary cost of living adjustment (COLA) for staff.

The Fatal School Violence Task Force, whose participants include administrators, law enforcement, crisis management specialists, and other stakeholders, is focused on providing resources to districts, preparation tools, crisis response and both state and federal advocacy. The board approved a \$25,000 budget for task force expenses.

The board is reviewing current policy related to campaigning rules for candidates seeking ACSA office, because of confusion about how to interpret the policy over the last few years. The board agreed that it is important for every candidate to have equal access and a level playing field when campaigning. A distinction was made between activities for campaigning and those that are of service to members. The board expressed support for allowing candidates to continue to serve our members and requested policy amendments to provide greater clarity and honor these concepts. The proposed amendments will be considered in July.

ACSA is getting close to finalizing the new Strategic Plan. Stakeholder feedback has been essential to every step of the process. During May/

June, region and committee/council leaders have been asked to present the draft plan for review and feedback. ACSA is providing tools to assist in making this an interactive and collaborative process. The Core Planning Group (CPG) provided a status update and project timeline as follows:

- May 25 - June 29: Regions and Committees/Councils present draft and get feedback.
- June 29: Stakeholder feedback due.
- July 18: Final draft published for board consideration.
- July 25: ACSA Board considers the plan for approval.

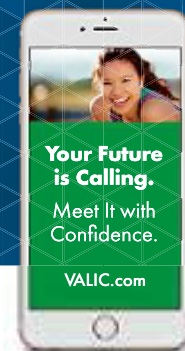

Region XI educational leaders advocate for students at Legislative Action Day

More than 400 educational leaders, representing all of ACSA's 19 regions, descended upon the State Capital for Legislative Action Day, Sunday and Monday, April 15 and 16. The event offered the opportunity to hear from inspirational speakers, learn about what's happening legislatively in education, network with fellow administrators and, most importantly, advocate for the 6.2 million students in California. ACSA's Governmental Relations team asked participants to focus on two key issues:

State Budget: Investments via the Local Control Funding Formula

BACKGROUND: The total dollar amount allocated in the California state budget for education is too low to provide the comprehensive and constitutionally required education that all California students deserve. As we near the 30-year anniversary of the passage of Proposition 98, the state is still far from prioritizing California public education funding. The overarching goal of the Local Control Funding Formula (LCFF) is to improve academic outcomes

by directing additional funding to school districts that serve high-need students. The intent of the LCFF was for individual school districts to have more authority over their spending decisions, while also holding each district accountable for the student results. The LCFF established a new way to split Proposition 98 funding — however, the new funding distribution method did nothing to increase the total amount of funding.

ACSA'S ASK:

- Increase LCFF funding levels through the base grant, while maintaining the supplemental and concentration grant funding levels
- Create a new long-term education funding plan
- Support Muratsuchi's AB 2808, which establishes a higher LCFF base grant funded by growth within Proposition 98. The funding goal set within the LCFF should be adjusted to reflect current and future funding needs, and AB 2808 provides an avenue to achieve those objectives.

Extending the Probationary Period

BACKGROUND: For decades, the state and nation have discussed the adequate time period for an new teacher to be granted permanent status (tenure). A significant amount of research, policy discussions, and court involvement has surrounded the importance of a competent teacher to improving a student's education outcomes. This is particularly true for students who have little to no outside support for their educational accomplishments. California is facing a severe teacher shortage due to a high number of retirements, high turnover and a shrinking supply of new teachers entering the profession. Under current law, a new teacher hired by a school district is placed on probation. The probation period in California is up to two years. California is one of only five states that has a probationary period of two years or less. Because of statutory deadlines, California's probationary law is the shortest of all. Current law requires notification of certificated employees by March 15 of each year if they will be released from their teaching duties. In order to meet this deadline, a district begins preparing their non-reelect notices as early as November or December, meaning a school district is deciding whether to grant someone a 30-year career after only 15 to 18 months of observation. If a teacher is the most important individual for a student's academic success, then public policy must ensure that teachers receive the best opportunity to succeed. One policy decision to consider is extending the probationary period for new teachers in order to provide them the tools for long-term success.

ACSA'S ASK:

- Enact a legislative change that extends the teacher probationary period to three years
- Support Weber's AB 1220

On Sunday, Edgar Zazueta, ACSA's Senior Director of Policy and Governmental Relations, and his team, provided the general session with detailed briefings and guidance on these topics through a panel discussion, followed by breakout sessions, during which each region prepared their plan for meeting with their particular legislators. Just before participants headed out to the Capitol on Monday, tips on effective advocacy were provided by experts in the field Kevin Gordon, president of Capitol Advisors, and his partner, former Superintendent of Public Instruction Jack O'Connell.

Region XI's Terri Rufert, State ACSA Vice President of Legislative Action, opened the general session on day one. She thanked everyone for taking time away from their busy schedules and stressed the importance of advocacy, "The more your legislators see you ... the more the state board of education sees you ... the more likely they are to come to you and ask for your opinion."

Dr. Ilene Straus, Vice President, California State Board of Education, gave the keynote address on Sunday. She stressed the importance of talking about your

successes. "When you talk about what happens in your school, people listen to you," she said. "Think about the stories we tell to think about our successes." She said the priority we're looking at is best first instruction. The best we can do is get teachers to come to us, hire them and get them to stay. Two things that determine whether or not they stay are working conditions and support from their administrator.

Region XI team members had productive conversations with five legislators who represent the region — Assemblyman Vince Fong (District 34), Senator Jean Fuller (District 16), Assemblyman Rudy Salas (District 32), Senator Jim Vidak (District 14), and Assemblyman Devin Mathis (District 26). "Legislators were able to hear multiple perspectives and the impact their votes will have in our schools and why we need their support," said Rocio Muñoz, Assistant Superintendent, Educational Services, Richland Union School District.

Vice President of Legislative Action Craig Wheaton facilitated Region XI's participation in the event, as well as the discussions with the legislators. "It is powerful to see our elected officials listen to the educational experts from our region," he said. "The difference we make is that we advocate on behalf of our students ... this is evident in the stories shared by each of our members."

David Bowling, Assistant Superintendent, Instruction, with Wasco Union Elementary School District, strongly encouraged Region XI members to volunteer to participate in Leg Action Day on behalf of their charter next year. "Going to Sacramento and sitting down with local legislators in the capital is an eye-opening experience that helps one better understand the highly political perspective of the work we engage in as school administrators," he said.

Legislative Action Day 2019 will be April 7 and 8. If you're interested in participating, you are encouraged to contact your charter president.

Subsequent administrative positions were Program Director of Career Education, Assistant Superintendent of Educational Services and in 2010, I was elected Kings County Superintendent of Schools. My entire 30-year career has been with the Kings County Office of Education. All of this has been possible because of the love and support of my wife and children who endured many nights of dad being off to school, or coming home bruised from an encounter with a student, and then election campaigning. Also pushing along the way have been colleagues such as Barbara Zaino, Deanna Lynch, and Noah Lawson, to name just a few.

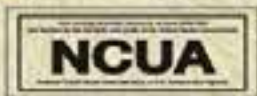

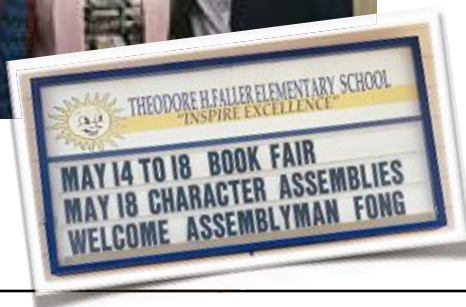

Human Resources Council

▶ The Human Resources (HR) Council gathered at the ACSA headquarters for the final meeting of the year on Thursday, May 3.

The group first met with representatives from the CTC to discuss the issue of credential auditing. The CTC is strongly advocating a move to *yearly* credential auditing, as opposed to the current 3 to 4 year rotation. County offices of education would still play an integral role, but the CTC is working on software that integrates with CALPADS. Despite concerns from the HR Council on the viability of two major systems communicating well (CALPADS and the one cur-

rently being devised to track credentialing) CTC staff members were positive their engineers will make it work. HR Council members asked how the CTC will handle all the unique names that each district give to their "classes." The simple response was that once each class is "processed" the first year, the system will recognize it the following year and apply the same rules previously established to determine if the teacher is credentialed for that particular class. Therefore, even if classes are named differently in each district, it should not be an issue.

In the afternoon, the group walked to the Capitol to meet with several legislative staff members regarding AB 1220. Members of the HR Council were chosen to present how a third year of probation for some new teachers would be beneficial in their district. The meetings were very productive, as the group was able to answer many questions from legislative staff. The team was also able to clear up many misconceptions that legislative staff members had regarding teachers and probation / permanent status.

The HR Council had one final conversation regarding the ACSA Personnel Institute, scheduled for October 2-4 in Emeryville. The HR Council is looking for more district presentations for the Personnel Institute; sessions where districts are presenting are many times rated the highest. Conference attendees indicate they appreciate hearing / seeing how other districts handle similar issues they are facing, as well as the innovative ways many districts have solved similar challenges. We have

tremendous presentations from a variety of attorney groups, and want to continue those, and so one other suggestion would be for a district interested in presenting might consider partnering with their law firm to do so.

Retirement Committee

▶ The State Retirement Committee met on March 28 in Sacramento at the CalSTRS building, a 15-story building which has housed the retirement services operations for the past ten years. The reason the committee met there was due to our ongoing concern about the planning that has been going on for several months to build a second tower to house staff for CalSTRS. \$8 million has been set aside for design work and \$180 million pledged to pay for the new building, should it get board approval in November, as well as approval from the Legislature.

The tour showed how impressive and wonderful a place to work the CalSTRS building is and how they are adding up to 150 new employees a year to their current 1,400 employees housed in the building. CalSTRS has been bringing in-house their investment staff rather than paying for contracted investment people from outside agencies. According to CalSTRS, in the first year of this change, \$200 million was saved without having to pay contractor fees and required bonuses.

As we toured the selected floors

of the building, we noticed a number of cubicles that were not occupied. While there were group meetings going on, there were still a lot of empty spaces which were not explained. The philosophy stated by CalSTRS staff was that they are planning for 30 years into the future. Our question was, since technology allows folks to work remotely, would that not relieve much of the pressure on the building, which is expected to reach full staff capacity by 2020. The stated reasons for adding to future staff is expansion of investment staff, Cybersecurity and other records security needs, along with communications, among others.

In November, the CalSTRS board will make a decision on two options, lease space somewhere in Sacramento, or go ahead with a plan to use some bare land on the current property to place portable buildings that would house up to 150 people to relieve stresses on the building space. It is the opinion of most of the committee that eventually the new building will be a reality, whether or not we or the other members of CalSTRS like it or not. Of course, a major concern is that in a situation where there is constant pressure on the retirement systems due to not having full funding to meet their long-term obligations, taking \$188 million out of the fund to pay for a new building is a major concern

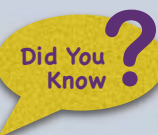
for those of us who are depending on the system to last our natural lifetimes.

On a secondary topic of discussion, the committee had several members appear to speak at the May board meeting of CalSTRS on the subject of the Supplemental Benefits fund which, as of May, will be valued at over \$11 billion. This is a fund that is restricted to use for one-time increases to members whose purchasing power has fallen below the statutory level. It also pays for death benefits to current retirees and members who pass away prior to retirement. Ironically, the death benefit for retirees, which as not been increased in over ten years, is over four thousand dollars less than the benefit for active members who pass away. Additionally, there are over 150 members over 100 years of age who receive less than \$970 per month in retirement. Our committee proposed that any one who retired prior to 1999 should receive a one-time increase in benefits. There was no action taken by the board on this issue. This fund has continued to grow over time and the worry our committee has is that if the fund is not used for the purpose for which it is intended, the legislature might decide to move that money into the regular retirement pool to boost the overall value of the fund.


In an effort to expand influence at the national level, ACSA is advocating the following federal priorities:
