- 2.3 The group discussed purchasing vouchers for the Leadership Conference and decided to decline the opportunity this year.

3.0 Reports

- 3.1 Region Past-President Steve Hovey
 - Steve reminded the group that the Awards Selection Committee would be selected at the next Delegate Assembly meeting.
- 3.2 President Alain Guevera
 - Alain discussed the professional development event. - 3.5 Vice President, Legislative Action Kiela Snider No report.
- 3.6 Vice President, Membership Yvonne McFadzean
 Yvonne provided an update of the membership indicating that State ACSA showed a 124
 member increase and Region XIX gained 6 members.
- 3.7 Newsletter/Website Kathy Beglau
 Kathy provided an overview of updated information on the Region Web site and usage statistics, and reminded the group of the September 27 newsletter deadline. She also brought forward a request from the Region Women's Leadership Network to create and maintain a Web page on the Region site. The group decided linking to the WLN Social Media pages would be appropriate.

 Sari provided a list of documents Charters need to provide to collect the \$250 rebate.
 She also announced that protégés and mentors are still be recruited for the mentoring program.
