to many meetings. Frank is quick to jump into a discourse on improving education - providing stimulating opportunities to discuss our profession which is all about helping students learn and grow. Frank is committed to improving our community and is a frequent writer of letters to the editor of the Modesto Bee.

Frank was born in Denver, Colorado, in 1912 and spent his formative years in Oregon on a simple farm. Times were tough so Frank and his

brother moved around the state of Oregon with their school teacher mother to towns that were "dots on a map with Plain Jane names."

Frank graduated from Gonzaga University in 1932 and moved to San Francisco where he went to San Francisco State to seek a teaching credential. He married Dorothy Grennan in 1940. Returning back to school, Frank graduated from UC Berkeley with a Ed.D. in 1958.

Frank has had an exciting career, taking him from the classroom to principal to assistant superintendent, all over the state of California. Frank's final position was in Stanislaus County as the Director of Elementary Education and later promoted to Assistant Superintendent of Stanislaus County Office of Education. He retired in 1975 but was able to spend 11 more years as a college instructor, supervisor of student teachers, and as a consultant.

CTE Update

SB70 Sunsets in 2012 - CDE and Community college want this funding to continue. Senate side of the house has shown interest in continuing funds. No definite strategies being discussed or planned at this time.

SB790 - Linked Learning Pilot - no funds come with this project; CDE to release some sort of RFP or other call to participate to 20 districts; Interested in beginning multiple pathways. CDE to possibly provide technical assistance and assist with outside resources – networking, contacts, etc.

AB1330 - CDE Putting together approval process on how to make this happen. Info to be released soon. This legislation allows CTE/ROP to count as a fine art requirement.

Budget

- Governor in his superflex plan has included AB8 funds (student organizations) to be part of the flexibility pot.
- Superflex excludes Special Ed and Nutrition.
- Funds can be used to support education without accountability.
- There will be pushback from several areas in regards to

ESEA - Elementary and Secondary Education Act Reauthorization. Pat Ainsworth believes it will include Career Pathway language. He is anticipating traveling to Washington D.C. a couple of times to discuss this reauthorization.

Visits - Diane Feinstein has indicated an interest in visiting strong Academies in the Bay Area of LA. Academies have the data that shows success rate.

The council met for their first face-to-face meeting in Sacramento on November 2, 2011, the day before the Leadership Summit. The Council welcomed the new Curriculum, Instruction, and Assessment Council chair, Sue Kaiser. Council members listened to a presentation by Karen Kearny (West Ed) on The Principal Evaluation Project. The handout: Assessing Principal Effectiveness: Research, Policy, and Best Practices to Use Now was provided to council members. Participants also listened to a teleconference with State Superintendent Tom Torlakson and Deputy Superintendent **Deb Sigman** regarding the waiver process for NCLB/ ESEA.

Raquel Tellez from the San Diego COE shared what they are doing to prepare for the implementation of the Common Core California Standards (CCCS). She explained the big shift to informational text. The theme is literacy in the content areas. George shared slides on Smarter Balanced, the new assessment with CCCS. He shared the beliefs of assessment designers and gave examples in each of the subject areas.

Sherry Shelly Griffiths gave the Governmental Relations update to the council. ACSA was successful in the co-(continued on page 7)

sponsorship of AB124, ensuring that CCCS are aligned with English Language Development standards. She stated that ACSA was moving forward to ensure a bridge to common core. ACSA is also working to educate the public regarding CCCS. They are assembling an advisory council in this area for work with the state board. They are pushing the message of alignment of: materials, assessments and standards. Sherry also shared the final report on the recommendations for the reauthorization of ESEA. They incorporated the Assessment

and Accountability Task Force recommendations. There is an emphasis on professional development and coaching for principals. Sherry reported on their trip to Washington D. C. to discuss NCLB and the concept of waivers. The House and Senate are all over the place with this. The last item Sherry addressed was testing for high school students. The question is how much testing to do at the secondary level: CST, AP, CAHSEE, etc. The governor also wants to revisit secondary assessments.
