

## **Classified Educational Leaders Council Meeting Summary/Report**

**May 17, 2023**

**In-Person Meeting at 1:00 pm**

**ACSA Office in Sacramento, CA**

- I. Welcome and Introductions by CEL Representatives from California
- II. Reviewed February Minutes (Zoom Meeting on 2/22/2023). Minutes were approved
- III. Government Relations and Update by Sylvan/Dorothy Johnson
  - a. LAD 2023 Wrap Up: May 18<sup>th</sup> will be the appropriations suspense file deadline which will set the tone for the remainder of the summer.
  - b. ACSA Currently working on the following:
    - i. AB 247 (Muratsuchi, Fong, M., Wilson): Amended to add \$14 billion dollar amount for the K-14 school bond and to revise the title to “Transitional Kindergarten through Community College School Bond.” Further amendments are to be determined as it will move through the Legislature before a final decision is made. The \$14 billion is intended for current and future projects; and up to 10% of entire bond will be set aside for specific school districts.
    - ii. SB 494 Termination of Superintendents must be done at a regular board meeting within the 72-hour notice guidelines. This agenda item can not be on a Special Board Meeting agenda.
    - iii. The Transitional Kindergarten higher standards for new teachers would not take effect for another two (2) years.
    - iv. The Governor’s May Revise of \$31.5 billion budget shortfall: proposing a fully funded COLA at 8.22% relies on a mechanism that uses one-time funding.
    - v. LAO says Governor’s budget is \$11 billion short of the mark as we are seeing an economic slowdown, which also has a lot of unknowns and uncertainty at this time. It’s hard to project what it to come.
    - vi. We will see a decline in the previously stated Arts & Music AMIM budget
    - vii. There will be an upcoming Leadership Change as Assembly Speaker, Robert Rivas will begin on July 1, 2023. More changes and new leadership could follow.
    - viii. There has been discussion that all districts change to a .gov email address, however, IT world is opposed to the changes as it can create lots of added work and possible cyber security issues.
