## **ACSA State Board Director- Juan Cruz**

### **Retirement Committee**

a. The members of the retirement committee request funds so that they can travel to D.C. with ACSA staff to advocate for retirement benefits at the federal level.

#### Leadership Assembly—Strategic Plan

a. Work was done to assess what regions are already doing to support the year one areas of focus and what other steps can be taken moving forward.

#### **Fatal School Violence Task Force**

a. An extensive discussion took place regarding the task force's recommendations. The Board was not able to reach consensus on one of the recommendations and President Edds will be working with staff to determine next steps.

#### **PAC**

- a. The Board discussed current policies and Procedures regarding endorsement of local elections.
- b. There is a provision that allows charters to request board approval to endorse local elections.
- c. This has been part of our policy but rarely utilized. This came to light when Burbank Charter requested to endorse a local parcel tax. The charter followed the appropriate steps and the Board approved the endorsement.
- d. There are a number of concerns with this policy and the Board has directed staff to bring back recommendations to our next meeting.

## **Legislative Action- Michael Gallager**

#### **Grass Roots Advocacy**

An important element of ACSA's new strategic plan is that each region and charter understands the importance of and is fully engaged in advocacy. Charters are encouraged to consider making outreach with legislators an integral part of their activities. The first step is building relationships with legislators and then explaining ACSA's role and purpose. Consider inviting a legislator to an ACSA meeting to speak, to receive an award, or to hand out an award. When you do this, take the extra step of sharing challenges and successes in your schools, district, and/or charter, and the impact policy can make on these challenges and successes.

Our local legislators all care about our public schools. We would like them to think of ACSA as a source of good information about the impact of policy decisions.

## Committee/Council Reports

## **Business Services- Chris Jew**

The Business Services Council met October 18, 2018 in Sacramento ACSA Office. The Council discussed the political landscape and unresolved issues for 2019. ACSA staff shared information from a recent interview with Gubernatorial candidate Gavin Newsom. For some of the highlights from the interview, click **HERE**.

The Council had Mike Fine, CEO of FCMAT, as a guest speaker. Mike reminded everyone that LCFF funding growth has been 13% over the last couple of years, now it will be just COLA only going forward. He stated that Proposition 98 is not going to be grow enough to cover the projected 2.5% - 3% COLA growth in the coming years. Mike reviewed AB 1840 - Education Trailer Budget Bill and early warning indicators for districts in fiscal distress. The trailer bill included quite a bit of policy language. With AB 1840, it shifts emergency appropriations from being a state-centric process to a county-centric process. Through AB 1840, FCMAT will automatically engage with districts if their budgets are disapproved, have a certified negative interim report, have three consecutive qualified interim reports, receive a downgrade of an interim report certification by the County Superintendent, or are designated with a "lack of going concern. FCMAT has revamped its Fiscal Health Risk Analysis Tool, weighting all sections and questions with a level of risk in order to provide more insight into the District's status based on their responses.

At the upcoming ACSA 2018 Leadership Summit, representatives from the Business Services Council will be presenting at the School Finance Strand Workshops. The planned topic areas are:

- The Silent Recession: District Budget Strategies for Challenging Times
- Build & Support Your Educational Program by Maximizing Local Assets
- Integrating Community Engagement, LCAP, and Collective Bargaining: It's All About Choices

## **Career Technical Education- Alyssa Lynch**

Last June, the Governor passed Legislation to allocate \$150 million dollars to Community Colleges Strong Workforce Programs and \$150 Million for CTEIG K-12 funds.. The combined \$300 million will be permanent ongoing funding for CTE

The new CTEIG applications will be released in mid-December and the application will be due January 25, 2019. Notification of Grant awards will be take place in May and funds will be allocated in June. Joelle Hanson is the new CTE Coordinator at Santa Clara County Office of Education. The Palo Alto Management Association (PAMA) has over 80 members of principals, coordinators, directors, and school psychologists. The board this year includes:

PAMA is building a relationship with our new superintendent, Dr. Don Austin. In addition, we are exploring

options to strengthen the existing Memorandum of Understanding with the district and Board of Education. During the 2016-17 school year, the board voted to remove the umbrella clause (or "me too" raises) for administrators. PAMA now participates in a meet and confer process. During the 17-18 school year, PAMA was able to negotiate a 1% raise on the salary schedule, with a 1% off the salary schedule compared to the 3% raise of the teacher's union received. Palo Alto Management Association invited the American Federation of School Administrators (AFSA) to present to administrators in late May and explored the idea of unionizing as an administrative group. At this time, we have decided to hold off on moving forward with AFSA.

We've held two meetings so far in August and October. We were all pleased to see our school bond measure pass from the November 6th election. We are planning our holiday party in December and our next meeting will be in January.
